Authorization to abolish two (2) vacant classified positions of Public Service Worker Sr. (Grade 509N), two (2) vacant classified positions of Public Service Worker Sr. (Grade 509) in the Divisions of Streets & Roads and Water Quality and one (1) vacant classified position of Equipment Operator Sr. (Grade 512N) in the Division of Waste Management and also create two (2) unclassified positions of Public Works Apprentice (Grade 504N) in the Division of Streets & Roads, two (2) unclassified positions of Public Works Apprentice (Grade 504N) in the Division of Water Quality and two (2) unclassified positions of Public Works Apprentice (Grade 504N) in the Division of Waste Management, effective upon passage by Council.
