Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to

reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and

hereby are authorized and directed:

Sewer Construction Fund; and the various Grant funds that do not result in changes to the Unappropriated Fund Balance of these
