Authorization to execute a Jobs Fund Incentive Agreement with Space Tango, Inc. for \$100,000 for the creation of seven (7) new jobs at a mean hourly wage of \$34.07 and a median hourly wage of \$36.06. On 05/14/2018, the Economic Development Investment Board reviewed an application for incentives from Space Tango, Inc.. The board voted unanimously to approve an incentive in the amount of \$100,000 for Space Tango for the creation of seven (7) jobs as part of the Co.'s expansion in Lexington. Funds are Budgeted.
