BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized and directed to execute the Amendment to the Agreement, which is attached hereto and incorporated herein by reference, with Bluegrass Care Navigators for the continued operation of a Medical Respite Care Program.

Section 2 - That an amount, not to exceed the sum of \$80,731.01, be and hereby is approved for payment to Bluegrass Care Navigators, from account #1145-155003-78112, pursuant to the terms of the Agreement.
