BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute options extending for one (1) year the Purchase of Service Agreements currently in place with the following organizations: (1) Jubilee Jobs of Lexington, Inc. and Lexington Rescue Mission, Inc.; (2) Opportunity Workshop of Lexington, Inc. d/b/a Opportunity for Work and Learning, Inc.; (3) Community Action Council for Lexington-Fayette, Bourbon, Harrison, and Nicholas Counties, Inc.; (4) Building Industry Association of Central Kentucky d/b/a Building Institute of Central Kentucky; (5) Urban League of Lexington - Fayette County, Inc.; (6) Build Inclusion, Inc.; and (7) Community Ventures Corporation.

Section 2 - That an amount, not to exceed the total sum of \$197,500.00, be and hereby is

approved for payment to (1) Jubilee Jobs of Lexington, Inc. and Lexington Rescue Mission, Inc. (\$59,500.00); (2) Opportunity Workshop of Lexington, Inc. d/b/a Opportunity for Work and Learning, Inc. (\$26,000.00); (3) Community Action Council for Lexington-Fayette, Bourbon, Harrison, and Nicholas Counties, Inc. (\$26,000.00); (4) Building Industry Association of Central Kentucky d/b/a Building Institute of Central Kentucky (\$26,000.00); (5) Urban League of Lexington - Fayette County, Inc. (\$22,500.00); (6) Build Inclusion, Inc. (\$20,000.00); and (7) Community Ventures Corporation (\$17,500.00), all from account number 1101-136101-0001-78103, pursuant to the terms of the respective Purchase of Service Agreements.
