Section 2 -That an amount, not to exceed the sum of \$53,000.00, be and hereby is approved for payment to Integration Partners in Fiscal Year 2019, and an additional amount, not to exceed the sum of \$12,000.00, be and hereby is approved for payment to Integration Partners each fiscal year thereafter that services are provided from account 1105-210101-0001-96201, pursuant to the terms of the attached Agreements.

Section 3 - That this Resolution shall become effective on the date of its passage.
