BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY

GOVERNMENT:

Section 1 - That Section 5-29(2) of the Code of Ordinances of the Lexington-Fayette Urban

County Government be and hereby is amended to read as follows:

Sec. 5-29 (2)

For the construction of commercial and other non-residential structures, the director, div. of Building Inspection shall receive the following fees based

on intended use, and in no event shall the fee be less than \$250.00.

- a. \$0.09 per square foot for restaurant use
- b. \$0.09 per square foot for educational use
- c. \$0.068 per square foot for hotel and motel use
- d. \$0.062 per square foot for office use
- e. \$0.042 per square foot for retail sales use
- f. \$0.042 per square foot for canopies
- g. \$0.028 per square foot for warehouse use
- h. \$0.042 per square foot for all other non-residential uses

Section 2 - That this Ordinance shall become effective on July 1, 2019.
