WHEREAS, the Lexington-Fayette Urban County Government has created a Geographic Information System ("GIS"); and

WHEREAS, the GIS street mapping and addressing project is the foundation for the Urban County Government's enhanced 911 Emergency Telephone Communication System (the "911 System"); and

WHEREAS, in order for the GIS and 911 Systems to function properly it is imperative that street names and property addresses conform to the standards established in Section 17-2 through 17-4 of the Code of Ordinances; and

WHEREAS, various street names and property addresses located in several Council Districts do not meet the Code requirements and changes should be made to conform to the Code and to accomplish the goals of the GIS and 911 System projects.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the spelling of the property address street name be corrected from Winnepeg Way to Winnipeg Way for property addresses located at 4011 through 4119.

Section 2 - That the street names and property address numbers of the following properties be and hereby are changed as follows:

- (a) Mary Fay Place: That the name of Mary Fay Place located at 2214 is changed to Providence Place Parkway and the following number changes are made:

2214 Mary Fay Place	1255 Providence Place Parkway

- (b) Greendale Road: That the name of Greendale Road located at 1075 and 1100 is changed to Mulundy Way and the following number changes are made:

<u>Current</u>	<u>New</u>
1075 Greendale Road	2420 Mulundy Way
1100 Greendale Road	2400 Mulundy Way

- (c) Todds Road: That the name of Todds Road located at 4131 and 4135 is changed to Polo Club Boulevard and the following number changes are made:

4131 Todds Road	3801 Polo Club Boulevard
4135 Todds Road	3775 Polo Club Boulevard

- (d) Old Richmond Road: That the name of Old Richmond Road located at 8622 is changed to Adams Lane and the following number changes are made:

<u>Current:</u>	<u>New:</u>
8622 Old Richmond Road	8622 Adams Lane

Section 3 - That this Resolution shall be effective thirty (30) days from passage.
