Section 1 - That the Zoning Ordinance of the Lexington-Fayette Urban County Government

be amended to show a change in zone for property located at 1812 Versailles Road from a Two

Family Residential (R-2) zone to a Planned Neighborhood Residential (R-3) zone, for 3.82 net (3.92)

gross) acres, being more fully described in Exhibit "A" which is attached hereto and incorporated

herein by reference.

Section 2 - That the Lexington-Fayette Urban County Planning Commission is directed to

show the amendment on the official zone map atlas and to make reference to the number of this

Ordinance.

Section 3 - That this Ordinance shall become effective on the date of its passage.
