) \$25,304.34 from the Unappropriated Fund Balance in the Police Confiscated Federal Fund to various accounts.

) \$31,780.00 from the Unappropriated Fund Balance in the Municipal Aid Program Fund to various accounts.

) \$261,295.68 from the Unappropriated Fund Balance in the County Road Aid Fund to various accounts.

) \$30,760.04 from the Unappropriated Fund Balance in the Mineral Severance Fund to various accounts.

) \$144,978.11 from the Unappropriated Fund Balance in the Sanitary Sewer Revenue and Operating Fund to various accounts.

) \$103,006.42 from the Unappropriated Fund Balance in the Water Quality Management Fund to various accounts.

) \$385,012.97 from the Unappropriated Fund Balance in the Landfill Fund to various accounts.

) \$22,000.00 from the Unappropriated Fund Balance in the Enhanced 911 Fund to various accounts.
