BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That Section 2-151(a) of the Code of Ordinances of the Lexington-Fayette Urban County Government be and hereby is amended to read as follows:

Sec. 2-151. - Members; terms.

(a) The Keep Lexington Beautiful Commission shall consist of fourteen (14) members appointed by the Mayor and confirmed by a majority of the Urban County Council as follows:

- (1) One (1) member shall be the Executive Director of Bluegrass Greensource.
- (2) One (1) member shall be an Urban County Council member.
- (3) One (1) member shall be from the Department of Environmental Quality and Public Works.
- (4) One (1) member shall be from the Division of Code Enforcement.
- (5) One (1) member shall be from the Division of Police.

The remaining members shall to the extent possible represent the below-listed constituencies:

- (6) One (1) member representing educational institutions.

- (7) One (1) member representing the equine/agricultural community.
- (8) One (1) member representing the beverage or fast food industries.
- (9) One (1) member representing the tourism industry.
- (10) Five (5) members appointed from the community at large.

Section 2 - That this Ordinance shall become effective on the date of its passage.
