WHEREAS, KRS 61.820 provides that all public agencies of the state shall provide for a schedule of regular

meetings by Ordinance, order, Resolution, bylaws, or whatever other means May be required for the conduct

WHEREAS, Section 2-1(a) of the Code of Ordinances of the Lexington-Fayette Urban County Government provides for adopting a schedule of dates and times of meetings to be adopted annually by Ordinance;
