authorized, in her discretion as Chief Executive Officer of the Urban County Government, to transfer

the unencumbered balance of any operating or capital account appropriation to another operating or

capital account appropriation within the Grant Budget established herein.

Section 3 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be

and hereby is authorized and directed to execute the Agreement, which is attached hereto and

incorporated herein by reference, with the Fayette County Commonwealth's Attorney's Office, for a full-time prosecutor for the Street Sales Drug Enforcement Project.

Section 4 - That an amount, not to exceed the sum of \$95,300.00 for FY 2020, be and hereby is approved for payment to the Fayette County Commonwealth's Attorney's Office from account #3140-112006-71101, pursuant to the terms of the Agreement.

Section 5 - That this Resolution shall become effective on the date of its passage.
