WHEREAS, at a Public Hearing held on October 24, 2019, a petition for a zoning Ordinance

map amendment for property located at 2575 Polo Club Boulevard (a portion of) from an Agricultural

Rural (A-R) zone to an Expansion Area Residential (EAR-1) zone for 26.34 net (27.19 gross) acres

and an Expansion Area Residential (EAR-2) zone, for 11.92 net (13.30 gross) acres, was presented

to the Urban County Planning Commission; said Commission recommending approval of the zone

change by a vote of 7-0; and

WHEREAS, this Council agrees with the recommendation of the Planning Commission; and WHEREAS, the recommendation form of the Planning Commission is attached hereto and incorporated herein by reference.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Zoning Ordinance of the Lexington-Fayette Urban County Government be amended to show a change in zone for property located at 2575 Polo Club Boulevard (a portion of) from an Agricultural Rural (A-R) zone to an Expansion Area Residential (EAR-1) zone for 26.34 net (27.19 gross) acres and an Expansion Area Residential (EAR-2) zone for 11.92 net (13.30 gross) acres, being more fully described in Exhibit "A" which is attached hereto and incorporated herein by reference.

Section 2 - That the Lexington-Fayette Urban County Planning Commission is directed to show the amendment on the official zone map atlas and to make reference to the number of this Ordinance.

Section 3 - That this Ordinance shall become effective on the date of its passage.
