NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for funds in the \$4,000.00 to provide funds for Council Projects in the Division of Parks and Recreation to purchase two picnic tables for Meadowbrook Park and that to effect such Amendments the following appropriations be and hereby are authorized and directed:
