## **Legislation Text**

An Ordinance expanding and extending Partial Urban Services District #4 for the Urban County Government for the provision of street lighting, to include the area defined as certain properties on the following streets: Carrie Circle and Mandeville Way. [Dept. of Environmental Quality and Public Works, Hoskins-Squier]

WHEREAS, pursuant to Section 2.04 of the Charter of the Lexington-Fayette Urban County

Government, Resolution No. 619-2017 was enacted by the Urban County Council on October 12,

2017, specifying the intention of the Urban County Government to expand and extend Partial Urban

Services District #4; and

WHEREAS, pursuant to Section 2.04 of the Charter of the Lexington-Fayette Urban County

Government, Resolution No. 619-2017 was published in the Lexington Herald-Leader; and

WHEREAS, pursuant to KRS 67A.860, certified letters were mailed to property owners to be

affected by the expansion and extension of Partial Urban Services District #4, informing them of the

proposed expansion and extension and the time and place of a public hearing; and

WHEREAS, pursuant to Section 2.04 of the Charter of the Lexington-Fayette Urban County

Government and KRS 67A.860, a public hearing was held on November 10, 2015, to inform and

receive the views of all interested persons concerning the expansion and extension of Partial Urban

Services District #4.

NOW, THEREFORE, PURSUANT TO SECTION 2.04 OF THE CHARTER OF THE

LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT AND KRS 67A.150, BE IT ORDAINED

BY THE COUNCIL OF THE LEXINGTON-FAYETTE COUNTY GOVERNMENT:

SECTION 1 - That Partial Urban Services District #4 for the Lexington-Fayette Urban County

Government, for the provision of street lighting, be and hereby is expanded and extended to include

SECTION 2 - That the Lexington-Fayette Urban County Government will provide the partial urban service of street lighting in order to provide well-lit, safe streets to deter crime and to contribute to traffic safety to the area defined as the properties, lots, tracts, and parcels of land listed in Section 1 above, on or before the effective date of this Ordinance.

SECTION 3 - That this Ordinance shall become effective on July 1, 2018.
