A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to execute and submit a Grant Application to the Ky. Transportation Cabinet, and to provide any additional information requested in connection with this Grant Application, and to accept this Grant if the application is approved, which Grant funds are in the amount of \$180,000 Federal funds, for the Nicholasville Rd. Corridor and Planning Study, the acceptance of which obligates the Urban County Government for the expenditure of \$45,000, and authorizing the Mayor to transfer unencumbered funds within the Grant Budget. Authorization to submit application requesting federal funding in the amount of \$180,000 from the Kentucky Transportation Cabinet, and accept award if offered, for the Nicholasville Road Corridor & Planning Study. Match in the amount of \$45,000 is required. Budget Amendment is in process. (L0216-18) (Duncan/Paulsen)
