WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County

URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to correct Budget related to purchase orders rolled to FY 2019 and purchase orders expensed to FY 2018, and that to effect such Amendments the following appropriations be and hereby are authorized and directed:

) \$_18,611.27_ _from_ the Unappropriated Fund Balance in the Police Confiscated Federal Fund _to_ various accounts.

) \$_3,969.83_ _from_ the Unappropriated Fund Balance in the Police Confiscate State Fund _to_ various accounts.

) \$ 850.00 from the Unappropriated Fund Balance in the Mineral Severance Fund to various accounts.

-) \$_248,073.36_ _from_ the Unappropriated Fund Balance in the Sanitary Sewer Revenue and Operating Fund _to_ various accounts.

 -) \$_3,099.53_ _from_ the Unappropriated Fund Balance in the Landfill Fund _to_ various accounts.
