WHEREAS, it is necessary and proper to amend the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for the Division of Environmental Services for funds in the amount of \$1,000.00 from Neighborhood Development Funds for Tree Week planting event at Beaumont Park:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:
