A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to execute and submit a Grant Application to the Ky. Justice and Public Safety Cabinet, to provide any additional information requested in connection with this Grant Application and to accept this Grant if the application is approved, which Grant funds are in the amount of \$134,889 Federal funds, under the Victim Assistance Formula Grant, and are for the implementation of the Underserved Minority Victims Advocacy Program for the Dept. of Social Services, the acceptance of which obligates the Urban County Government for the expenditure of \$33,723 as a local match, and authorizing the Mayor to transfer unencumbered funds within the Grant Budget. [Dept. of Social Services, Theakston]

Authorization to submit an application and accept award, if offered, to the Kentucky Justice and Public Safety Cabinet requesting Federal funds in the amount of \$134,889 under the Victim Assistance Formula Grant funded by the Victims of Crime Act. Match in the amount of \$33,723 is required and has been Budgeted. (L0590-19) (Theakston/Ford)

and hereby is authorized and directed to execute and submit the Grant Application, which is attached

to provide any additional information requested in connection with this Grant Application, and to

accept this Grant if the application is approved, which Grant funds are in the amount of \$134,889.00

Federal funds, under the Victim Assistance Formula Grant, and are for the implementation of the

Underserved Minority Victims Advocacy Program for the Department of Social Services, and the

acceptance of which obligates the Lexington-Fayette Urban County Government for the expenditure

of \$33,723.00.

Section 2 - That subject to the provisions of Ordinance No. 22-79, the Mayor is hereby

authorized, in her discretion as Chief Executive Officer of the Urban County Government, to transfer

the unencumbered balance of any operating or capital account appropriation to another operating or

capital account appropriation within the Grant Budget previously established for this Grant.
