(\$500.00); LFUCG — PARTNERS FOR YOUTH (\$800.00); THE SALVATION ARMY (\$1,000.00); LOUISIANA AVENUE NEIGHBORHOOD ASSOCIATION, INC. (\$500.00); BLUEGRASS FAMILIES FIRST, INC. (\$1,100.00); SISTERS & SUPPORTERS WORKING AGAINST GUN VIOLENCE INC (\$2,000.00); KENTUCKY SOCIETY, SONS OF THE AMERICAN REVOLUTION, INC. (\$950.00); AND BLACK CHURCH COALITION OF THE BLUEGRASS, INC. (\$2,150.00), FOR THE OFFICE OF THE URBAN COUNTY COUNCIL, AT A COST NOT TO EXCEED THE SUM STATED.

BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:
