WHEREAS, the parties desire to amend said agreement;


NOW THEREFORE, in consideration of the following promises and covenants contained herein the parties hereby agree as follows:





RESOLUTION NO. 602 - 2018

A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE URBAN COUNTY GOVERNMENT, TO EXECUTE AN AGREEMENT WITH THE KENTUCKY TRANSPORTATION CABINET, FOR THE ACCEPTANCE OF FEDERAL FUNDS IN THE AMOUNT OF \$608,131.20 FOR THE CONSTRUCTION OF THE WEST HICKMAN TRAIL PROJECT, THE ACCEPTANCE OF WHICH OBLIGATES THE URBAN COUNTY GOVERNMENT FOR THE EXPENDITURE OF \$152,032.80 AS A LOCAL MATCH.

BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That the Mayor, on behalf of the Lexington-Fayette Urban County Government, be and hereby is authorized to execute the Agreement, which is attached hereto and incorporated herein by reference, with the Kentucky Transportation Cabinet, for the acceptance of Federal funds in the amount of \$608,131.20 for the construction phase of the West Hickman Trail Project, the acceptance of which obligates the Urban County Government for the expenditure of \$152,032.80 as a local match.

Section 2 - That this Resolution shall become effective on the date of its passage.

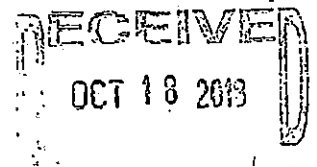
