THIS AGREEMENT, made and entered into on the 27th day of April, 2016 by and between the LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, an Urban County Government of the Commonwealth of Kentucky, created pursuant to KRS Chapter 67A (Hereinafter "Government"), on behalf of its Office of the Urban County Council, and Southpoint Residential Assoc. (Hereinafter "Organization"), of 201 Bittersweet Way, Fayette County, Lexington, KY 40515.

WHEREAS, Organization accordingly enhances the environment of Lexington; and


WHEREAS, Organization has demonstrated a need for additional monies to expand and develop its programs.

1. Government hereby grants Organization the sum of \$500, (Five Hundred Dollars and No Cents - LFUCG check #255290) To assist with the purchase and installation of neighborhood safety watch signs.
2. Organization shall provide equal opportunity in employment for all qualified persons; prohibit discrimination in employment because of race, color, creed, national origin, sex or age between 40 and 70; promote equal employment through a positive, continuing program of equal employment and cause each of its subcontracting agencies to do so. In any written or oral communications, the Organization shall identify the Lexington-Fayette Urban County Government as the source of the above-referenced funds; the Organization shall not specifically identify individual Councilmember as being responsible for the funds donated by the Lexington-Fayette Urban County Government.


