

AN ORDINANCE AMENDING THE UNCLASSIFIED CIVIL SERVICE AUTHORIZED STRENGTH BY ABOLISHING THREE (3) POSITIONS OF SOCIAL WORKER SR., GRADE 516E, AND ONE (1) POSITION OF SOCIAL SERVICES COORDINATOR, GRADE 520E, AND CREATING FOUR (4) POSITIONS OF FAMILY COURT SERVICES SPECIALIST, GRADE 516N, IN THE OFFICE OF CIRCUIT JUDGES, AND RECLASSIFYING THE INCUMBENTS, TRANSFERRING THE INCUMBENTS FROM EXEMPT TO NON-EXEMPT POSITIONS AND CONVERTING THEIR BIWEEKLY SALARIES TO HOURLY RATES OF PAY, EFFECTIVE THE BEGINNING OF THE NEXT PAY PERIOD FOLLOWING PASSAGE OF COUNCIL.

BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That subsection line numbers 164.020 and 164.050 in the unclassified civil service authorized strength be and hereby are deleted.

Section 2 – That the following subsection line number in the unclassified civil service authorized strength by and hereby is created to read as follows:

164.015      4      025    516N      Family Court Services Specialist

Section 3 – That the incumbents be and hereby are transferred from exempt positions to non-exempt positions.

Section 4 – That the incumbent, Angelica Maldonado, be and hereby is reclassified from Social Services Coordinator, Grade 520E, at \$1,946.72 biweekly, to Family Court Services Specialist, Grade 516N, at \$24.334 hourly.


Section 5 – That the incumbent, Barbara McCreary, be and hereby is reclassified from Social Worker Sr., Grade 516E, at \$2,285.68 biweekly, to Family Court Services Specialist, Grade 516N, at \$28.571 hourly.


Section 6 – That the incumbent, Davina Warner, be and hereby is reclassified from Social Worker Sr., Grade 516E, at \$1,898.56 biweekly, to Family Court Services Specialist, Grade 516N, at \$23.732 hourly.

Section 7 – That the incumbent, Sue Wingate, be and hereby is reclassified from Social Worker Sr., Grade 516E, at \$2,074.96 biweekly, to Family Court Services Specialist, Grade 516N, at \$25.937 hourly.

Section 8 – That this Ordinance shall become effective the beginning of the next pay period following passage of Council.
