Improvement Program (TIP) and Administrative Modification #34 to the 2045
Metropolitan Transportation Plan (MTP)

On March 4, 2022, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #15 to the FY 2021 – 2024 TIP and Modification #34 to the 2045 MTP.

Administrative Modification #15:

This action updates the previously published documents and tables. The modification updates the following two existing projects in Fayette County:

Mt. Tabor Multimodal Improvements

- Move \$100,240 (\$80,192 CMAQ + \$20,048 Local Match) from the Utilities phase to the Construction phase
- This update does not affect fiscal constraint, as it simply moves unused funds from one phase to another.

North Limestone Improvements

- Increase funds in the amount of \$4,290,000 (\$3,432,000 STBG-SLX + \$858,000 Local Match) as follows:
 - Design \$400,000 (\$320,000 STBG-SLX + \$80,000 Local Match)
 - Utilities \$220,000 (\$176,000 STBG-SLX + \$44,000 Local Match)
 - o Construction \$3,670,000 (\$2,936,000 STBG-SLX + \$734,000 Local Match)
- This update does not affect fiscal constraint, as the \$3,432,000 STBG-SLX increase was allocated from the available reserve and approved by the TPC on February 23, 2022. The \$858,000 increase in local match has also been identified by the Urban County Government.

In addition to the project funding updates, this modification also incorporates the Kentucky Transportation Cabinet Highway Safety Targets for 2022. The TPC approved the staff's recommendation to support the state targets and adopt them as the Lexington Area MPO targets on February 23, 2022.
