AN ORDINANCE AMENDING CERTAIN OF THE BUDGETS OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT TO REFLECT CURRENT REQUIREMENTS FOR MUNICIPAL EXPENDITURES, AND APPROPRIATING AND RE-APPROPRIATING FUNDS, SCHEDULE NO. 0005.

WHEREAS, it is necessary and proper to amend the budgets of the Lexington-Fayette Urban County Government to reflect current requirements for municipal expenditures:

-) \$_222,936.04_ _from_ the Unappropriated Fund Balance in Municipal Aid Program Fund _to_ various accounts.
-) \$_54,544.23_ _from_ the Unappropriated Fund Balance in County Road Aid Program Fund _to_ various accounts.
-) \$_115,609.50_ _from_ the Unappropriated Fund Balance in Miscellaneous Special Revenue Fund _to_ various accounts.
-) \$_841,746.56_ _from_ the Unappropriated Fund Balance in Sanitary Sewer Revenue and Operating Fund _to_ various accounts.
