**RECOMMENDATION OF THE  
URBAN COUNTY PLANNING COMMISSION  
OF LEXINGTON AND FAYETTE COUNTY, KENTUCKY**

**IN RE:** PLN-MAR-24-00014: SUBTEXT ACQUISITIONS, LLC – a petition for a zone map amendment from a Single Family Residential (R-1E) zone, a Planned Neighborhood Residential (R-3) zone and a Neighborhood Business (B-1) zone to a Corridor Node (CN) Zone, for 2.13 net (2.80 gross) acres for properties located at 545-549, 553, 563 S. Limestone; 121-123, 127, 129, 131, 133 Prall Street; 118, 120, 124, 128, 134, 138, 140, 142, 146, 150, and 154 Montmullin Street. (Council District 3)

Having considered the above matter on **October 24, 2024**, at a Public Hearing, and having voted **6-3** that this Recommendation be submitted to the Lexington-Fayette Urban County Council, the Urban County Planning Commission does hereby recommend **DISAPPROVAL** of this matter for the following reasons:

1. The requested Corridor Node (CN) zone does not agree with the 2045 Comprehensive Plan's Theme A, Goal 2, Objective B because it does not respect the context and design of the area's surrounding development project.
2. The requested Corridor Node (CN) zone does not protect existing housing affordability for all and expand low and middle income housing across the city, and specifically in the surrounding neighborhood.
3. The requested Corridor Node (CN) zone increases density far past the major corridor negatively impacting density within the existing residential neighborhood. (Theme A, Goal 1, Objective B).

  - Stated she was opposed to the gentrification of Pralltown.
  - Stated her opposition by accusing, without any evidence, city officials of corruption and stating this was another example of gentrification.
  - Stated his opposition to this development and his deep concern for the erosion of Pralltown.
  - Stated their strong opposition to the development because it does not represent Kentucky values.
  - Stated her opposition to this proposal and asked the Planning Commission to not let an unpleasant present become our entire history.
  - Stated that she opposed development.
  - Stated his opposition because these units would not be affordable and had concerns about the CN zone.
  - Stated her opposition because the proposed development does not provide varied housing choice and is not in agreement with the Comprehensive Plan.
  - Stated he had concerns about the due diligence of this project and questioned who represented the citizens of Lexington in this process.
  - Stated he did not mind progress, but the price for this is at the expense of Pralltown.
  - Stated her opposition because she thought that this development would destroy the neighborhood and noted her family's ties to Pralltown going back 140 years.
  - Stated his opposition because it does not fit with the context of the neighborhood and took issue with the \$1.5 million dollar donation.
  - Asked the Planning Commission to reject this proposal because the people of Pralltown would not be able to afford the affordable housing.
  - Stated his opposition.
  - Stated her opposition because she has seen projects displace families and is afraid of that result here.
