ORDINANCE NO. _____ - 2022

AN ORDINANCE AMENDING CERTAIN OF THE BUDGETS OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT TO PROVIDE FUNDS FOR PURCHASE ORDERS AND PRE-PAID EXPENSES ROLLING FROM FY 2022 INTO FY 2023, AND APPROPRIATING AND RE-APPROPRIATING FUNDS, SCHEDULE NO 0004.

WHEREAS, it is necessary and proper to amend the budgets of the Lexington-Fayette Urban County Government to provide funds for purchase orders and pre-paid expenses rolling from FY 2022 into FY 2023.

-) \$109,229.44 from the Unappropriated Fund Balance in the Police Confiscated Federal Fund to various accounts.
-) \$28,618.47 from the Unappropriated Fund Balance in the Police Confiscate State Fund to various accounts.
-) \$839,833.86 from the Unappropriated Fund Balance in the Municipal Aid Program Fund to various accounts.
-) \$182,473.45 from the Unappropriated Fund Balance in the County Road Aid Program Fund to various accounts.
-) \$130,770.10 from the Unappropriated Fund Balance in the Mineral Severance Fund to various accounts.
-) \$58,500.00 from the Unappropriated Fund Balance in the Coal Severance Fund to various accounts.
-) \$1,153.40 from the Unappropriated Fund Balance in the Affordable Housing and Homelessness Fund to various accounts.
-) \$3,201,566.98 from the Unappropriated Fund Balance in the Sanitary Sewer Revenue and Operating Fund to various accounts.
-) \$56,346.84 from the Unappropriated Fund Balance in the Public Facilities Fun General to various accounts.
-) \$91,375.51 from the Unappropriated Fund Balance in the Public Facilities Fund Parks Projects to various accounts.
-) \$447,757.83 from the Unappropriated Fund Balance in the Water Quality Management Fund to various accounts.

) $\$1,320,394.43$ from the Unappropriated Fund Balance in the Landfill Fund to various accounts.
) $\$30,250.43$ from the Unappropriated Fund Balance in the Right of Way Fund to various accounts.
) $\$819.00$ from the Unappropriated Fund Balance in the Extended School Fund to various accounts.
) $\$330,722.52$ from the Unappropriated Fund Balance in the Enhanced 911 Fund to various accounts.
) $\$146,\!883.23$ from the Unappropriated Fund Balance in the Central Kentucky 911 Fund to various accounts.
) $$122,969.25$ from the Unappropriated Fund Balance in the Medical Insurance Fund to various accounts.
