) \$23,371.00 to the General Services District Fund from various accounts.

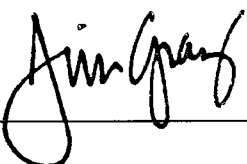
) \$25,371.00 from the Enhanced 911 Fund to various accounts.
