ORDINANCE NO. _____ 2025

AN ORDINANCE AMENDING SECTION 5-76(1) OF THE CODE OF ORDINANCES RELATED TO REQUIRED FEES FOR ELCETRICAL WIRING WORK NOT EXCEEDING THIRTY THOUSAND (\$30,000.00) DOLLARS TO INCREASE THE RATES AS FOLLOWS: ROUGH WIRE INSPECTIONS FOR THE FIRST 10 (TEN) CIRCUITS FROM \$55.00 TO \$65.00, REWIRE INSPECTIONS FROM \$55.00 TO \$65.00, RE-INSPECTION FROM \$35.00 TO \$45.00, FINAL INPSECTION FROM \$55.00 TO \$65.00 FOR UP TO 10 (TEN) CIRCUITS, TEMPORARY ON PERMANENT INSPECTIONS FROM \$55.00 TO \$65.00, MANUFACTURED OR MOBILE HOME FROM \$55.00 ТО \$65.00, APARTMENTS-ROUGH WIRE SERVICE TEMPORARY INSPCETION FROM \$35.00 TO \$55.00 AND APARTMENTS-FINAL INSPECTIONS FROM \$35.00 TO \$55.00; AMENDING SECTION 5-76(2) OF THE CODE OF ORDINANCES RELATED TO REQUIRED FEES TO CHANGE FEES ON CONTRACTS FOR \$40,000.00 AND ABOVE TO CONTRACTIS FOR \$30,000.00 AND ABOVE TO 1(ONE) PERCENT OF THE TOTAL COST.

BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN

COUNTY GOVERNMENT:

Section 1 - That Section 5-76(1) of the Code of Ordinances, Lexington-Fayette

Urban County Government, be and hereby is amended to read as follows:

Sec. 5-76(1) For inspection of electrical wiring work not exceeding thirty thousand dollars (\$30,000.00) in cost:

Rough wire inspection:

\$55.00 <u>\$65.00</u> for the first 10 circuits.

\$0.65 each circuit over 10 and up to 20.

\$0.40 each for all over 20.

Rewire inspection:

\$55.00 \$65.00 for service change inspection.

Reinspection because of turndown:

\$35.00 \$45.00 per inspection.

Final inspection:

\$55.00 \$65.00 for service and fixtures up to 10 circuits.

\$0.40 for each fixture over 10.

\$1.10 for each 240-vot motor and appliance circuits.

Temporary inspection:

\$55.00 <u>\$65.00</u>

Manufactured or mobile home services:

\$55.00 \$65.00 for inspection of manufactured or mobile homes without state approval.

Apartments – rough wire and temporary on permanent inspections:

\$35.00 <u>\$55.00</u> per unit per inspection.

Apartments – final inspection.

\$35.00 <u>\$55.00</u> per unit per inspection.

\$1.10 for each 240-volt appliance circuit.

\$1.10 for each small appliance circuit.

Section 2 - That Section 5-76(2) of the Code of Ordinances, Lexington-Fayette

Urban County Government, be and hereby is amended to read as follows:

Sec. 5-76(2) Contracts of forty thirty thousand dollars (\$40,000.00 \$30,000.00)

and above:

The rate for inspections for electrical wiring work including all owner furnished materials costing more than forty thirty thousand dollars (\$40,000.00 \$30.000.00) shall be one percent of the total cost. for the first one million dollars (\$1,000,000.00). The rate shall be downward of three quarters (3/4) of one percent for anything over one million dollars (\$1,000,000.00).

Section 3 - That this Ordinance shall become effective on the date of its passage.
