Section 2 - That an amount, which is estimated not to exceed the sum of \$61,637.00 (FY2013), be and hereby is approved for payment to Burdine Security Group, Inc., from account #2602-707501-91012 pursuant to the terms of the agreement.

Price Contract for a Service Agreement with Burdine Security Group Inc. for repair, replacement and maintenance of LFUCG's electronic access control

system in response to RFP #10-2013.

I am requesting Urban County Council approval to enter into a service contract with Burdine Security Group Inc. for the repair, replacement, and maintenance of LFUCG's electronic access control system. All labor, materials, supplies and other required items shall be completed as described in RFP #10-2013, Scope of Services. The initial term of the agreement is for a period of three (3) year and may be renewed for two (2) additional one year terms, subject to future appropriation funding. The cost to replace existing access control panels, software, proximity readers, verification of existing locking devices for accuracy and function, and replacement of access controls as specified in the agreement is \$61,637 and the cost for the 3 year warranty is \$19,741. Extended warranty and maintenance cost for each year 4 and 5 of the agreement is \$9,880 per year.
