

PURCHASE OF SERVICE AGREEMENT

THIS PURCHASE OF SERVICE AGREEMENT (hereinafter "Agreement"), made and entered into on the 30th day of ^{August} ~~MONTH~~ 2021, by and between the **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, an urban county government of the Commonwealth of Kentucky created pursuant to KRS chapter 67A (hereinafter "Government"), 200 East Main Street, Lexington, Kentucky 40507, on behalf of its Department of Social Services (hereinafter "Sponsor"), and **FOODCHAIN**, with offices located **501 WEST SIXTH STREET, SUITE 105, LEXINGTON KY 40508**, (hereinafter "Organization").

WITNESSETH

That for and in consideration of the mutual promises and covenants herein expressed, the Government and the Organization agree as follows:

1. Government hereby retains Organization for the period beginning on **July 1, 2021**, and continuing for a period of one (1) year from that date unless within that period Government gives the Organization thirty (30) days written notice of termination of this Agreement in which case this Agreement shall terminate thirty (30) days from the date notice is given to the Organization.
2. Government shall pay Organization the sum of **\$63,878** for the services required by this Agreement, said services being more particularly described in the Addendum attached hereto and incorporated herein by reference as Exhibit A, one-half (1/2th) of which shall be payable in September 2021 or shortly thereafter upon receipt of an invoice, with one-half (1/2th) payable in January 2022 or shortly thereafter upon receipt of an invoice and the first six month detailed program report., **The first invoice required by this section shall be submitted by September 17th, 2021. The second invoice and the first six month detailed program report shall be due January 21st 2022. A detailed program report shall be submitted by April 15th, 2022. A year-end program report shall be submitted by July**

22nd, 2022. Failure to submit the April 2022 program report and the July 2022 year-end program report shall result in the Organization repaying one-half (1/2th) of total funds provided under this Agreement. Reports shall reflect the services and programs directly related to the funding provided by Lexington Fayette Urban County Government with emphasis on measurable outcomes, and specifically outlined in the funding application. Forms for both the quarterly financial and program reports will be provided.

3. In the event of termination of this Agreement by Government as provided for in paragraph 1 above, Organization shall be entitled to that portion of total compensation due under this Agreement as the service rendered bears to the service required herein.

4. Organization shall perform all duties and services included in the Addendum attached hereto faithfully and satisfactorily at the time, place and for the duration prescribed herein. Compensation paid pursuant to this Agreement shall be used exclusively for the services set forth in the Addendum and for no other purpose. Any alteration in the nature of such services and duties constitutes an amendment to this Agreement and must be in writing signed by both parties. Organization shall keep itself fully informed of all federal and state laws and all municipal ordinances and regulations in any manner affecting the work or performance of this Agreement, and shall at all times observe and comply with such laws, ordinances and regulations, whether or not such laws, ordinances or regulations are mentioned herein, and

5. Organization shall indemnify, defend and hold harmless Government, its officers, agents and employees, from and against any and all liabilities, claims, demands, losses, damages, costs, and/or expenses arising out of, from, relating to, and/or based on the Organization's violation of any such laws, ordinances or regulations or Organization's breach of this Agreement.

6. Organization represents that it has filed all federal, state and local income tax returns required by law in the legally prescribed time and manner. This Agreement shall not become effective unless and until copies of all of the executed originals of the aforementioned tax returns filed for the Organization have been registered for the current tax year by the Organization in the office of the Sponsor, and the Organization shall not be compensated unless and until such registration has taken place.

7. The Organization shall, on such forms as the Sponsor shall provide, submit to Sponsor an annual report and financial statement which summarize the previous year's activities regarding the services enumerated in the addendum attached hereto.

8. Books of accounts shall be kept by the Organization and entries shall be made therein of all money, goods, effects, debts, sales, purchases, receipts, payments and any other transactions of the Organization. The books of accounts, together with all bonds, notes, bills, letters and other writings belonging to the Organization, shall be maintained at the principal place of business of the Organization as set forth in this Agreement. Government shall have free and complete access to the books, papers and affairs of the Organization, that relate to the performance of this Agreement, at all reasonable times, and if it desires, it may have the books and papers of the Organization, that relate to the performance of this Agreement, audited and examined by auditors, accountants or attorneys. Any examination shall be at the expense of the Government.

9. Government may designate such persons as may be necessary to monitor and evaluate the services rendered by the Organization. The Government, its agents and employees, shall, at all times, have unrestricted access to all places where or in which the services required hereunder are being carried on and conducted. Inspection and monitoring of the work by these authorities shall in no manner be presumed to relieve in any degree the

responsibility or obligations of Organization, nor to constitute the Organization as an agent of the Government.

10. Organization shall provide equal opportunity in employment for all qualified persons, shall prohibit discrimination in employment because of race, color, creed, national origin, sex or age, and shall cause each of its subcontracting agencies to do so. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

11. Organization shall adopt a written sexual harassment policy, which shall, at a minimum, contain a statement of current law; a list of prohibited behaviors; a complaint process; and a procedure which provides for a confidential investigation of all complaints. The policy shall be given to all employees and clients and shall be posted at all locations where Organization conducts business. The policy shall be submitted to Sponsor for review within thirty (30) days of the execution of this Agreement.

12. This instrument, and the Addendum incorporated herein, contains the entire agreement between the parties, and no statement, promises or inducements made by either party or agent of either party that is not contained in this written Agreement shall be valid and binding; and this Agreement may not be enlarged, modified or altered except in writing signed by the parties and endorsed hereon.

13. Organization agrees that it shall apply all funds received by it from the Urban County Government in accordance with the following investment policy guidelines:

- A. Objectives: Capital preservation with surety of income. Reasonable competitive income consistent with high investment quality and purpose of funds. All investments shall conform with state and local law and regulations and these policies.
- B. Investment Funds Management: The governing board may elect to either:

(1) Manage its investment through its executive director where the size or complexity of funds to be managed is deemed by the board to be within the training, expertise and/or available time capacity of the executive director and the operating staff; or

(2) Utilize the professional investment management facilities of a local bank trust department acting in a fiduciary capacity within the same approved investment policies and federal, state, local and trust laws and regulation. The trust department may utilize its regular short-term one hundred percent (100%) US Treasury Fund for daily funds investment.

The election of option 1 or 2 should be made consistent with the relative cost incurred and in the case of option 2 the cost shall be competitive among local trust departments.

C. Investment Policies - - Safety and Prudence.

(1) Short-term liquidity funds shall be invested in "riskless" investment, i.e., deposits in Kentucky commercial banks or savings and loan associations that are fully federally insured or deposits collateralized by U.S. Treasury securities with a current market value of at least one hundred percent (100%), or in direct obligations of U.S. Treasury securities.

Investments shall be diversified according to maturity in order to meet projected cash flow needs.

Collateral pledged to secure uninsured deposits shall be held at a federal reserve bank with the receipt providing absolute control by the agency.

(2) Retirement funds, endowment funds, long-term capital reserve funds and any other special funds may be held and invested by a local bank trust department under investment objectives and diversification in accordance with the individual nature of the funds and pursuant to the "prudent man" investment rule as well as general trust law.

(3) All investments shall be reviewed monthly by a finance or investment committee of the agency.

(4) Local brokerage firms may hold and invest funds provided that investments are located within Kentucky and are full insured.

D. Audit - - All investments shall be audited at least annually by independent certified public accountant who shall express an opinion as to whether or not investments during the year audited have conformed with state and local law and regulation and with the approved investment policies.

The Lexington-Fayette Urban County Government hereby requests proposals for **RFP #12-2021 Food Insecurity & Nutritional Access – Extended Social Resources (ESR) Grant Program** to be provided in accordance with terms, conditions and specifications established herein.

Proposals will be received **online only** at <https://lexingtonky.ionwave.net> until **2:00 PM**, prevailing local time, on **May 14, 2021**.

Proposals received after the date and time set for opening proposals will not be considered for award of a contract/grant. It is the sole responsibility of the Proposer to assure that his/her proposal is submitted online before the date and time set for opening proposals.

Additional copies of this Request For Proposals are available from the Division of Central Purchasing, Room 338 Government Center, 200 East Main Street, Lexington, KY 40507, (859)-258-3320, at no charge.

Proposals, once submitted, may not be withdrawn for a period of sixty (60) calendar days.

The Lexington-Fayette Urban County Government reserves the right to reject any or all proposals, and to waive technicalities and informalities when such waiver is determined by the Lexington-Fayette Urban County Government to be in its best interest.

Electronic signature online at <https://lexingtonky.ionwave.net> constitutes acceptance by the Proposer of terms, conditions and requirements set forth herein.

Pre-Proposal Meeting will be held on **April 30th, 2021 at 10:00AM EST** via Zoom (see section 3.1 in Scope of Work document for meeting link).

Minor exceptions may not eliminate the proposal. Any exceptions to the specifications established herein shall be listed in detail on a separate sheet and attached hereto. The Lexington-Fayette Urban County Government shall determine whether any exception is minor.

Please do not contact any LFUCG staff member or any other person involved in the selection process other than the designated contact person(s) regarding the project contemplated under this RFP while this RFP is open and a selection has not been finalized. Any attempt to do so may result in disqualification of the firm's submittal for consideration.

Laws and Regulations

All applicable state laws, municipal ordinances and regulations of all authorities having jurisdiction over the project shall apply to the contract, and shall be deemed to be incorporated herein by reference.

Equal Employment Opportunity

The Entity (regardless of whether construction contractor, non-construction contractor or supplier) agrees to provide equal opportunity in employment for all qualified persons, to prohibit discrimination in employment because of race, color, creed, national origin, sex or age, and to promote equal employment through a positive, continuing program from itself and each of its subcontracting agents. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

Kentucky Equal Employment Opportunity Act

The Kentucky Equal Employment Opportunity Act of 1978 (KRS 45.560-45.640) requires that any "county, city, town, school district, water district, hospital district, or other political subdivision of the state shall include in directly or indirectly publicly funded contracts for supplies, materials, services, or equipment hereinafter entered into the following provisions:

"During the performance of this contract, the contractor agrees as follows:

(1) The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin;

(2) The contractor will state in all solicitations or advertisements for employees placed by or on behalf of the contractors that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, age, or national origin;

(3) The contractor will post notices in conspicuous places, available to employees and applicants for employment, setting forth the provision of the nondiscrimination clauses required by this section; and

(4) The contractor will send a notice to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding advising the labor union or workers' representative of the contractor's commitments under the nondiscrimination clauses."

The Act further provides:

"KRS 45.610. Hiring minorities -- Information required

(1) For the length of the contract, each contractor shall hire minorities from other sources within the drawing area, should the union with which he has collective bargaining agreements be unwilling to supply sufficient minorities to satisfy the agreed upon goals and timetables.

(2) Each contractor shall, for the length of the contract, furnish such information as required by KRS 45.560 to KRS 45.640 and by such rules, regulations and orders issued pursuant thereto and will permit access to all books and records pertaining to his employment practices and work sites by the contracting agency and the department for purposes of investigation to ascertain compliance with KRS 45.560 to 45.640 and such rules, regulations and orders issued pursuant thereto.

KRS 45.620. Action against contractor -- Hiring of minority contractor or subcontractor

(1) If any contractor is found by the department to have engaged in an unlawful practice under this chapter during the course of performing under a contract or subcontract covered under KRS 45.560 to 45.640, the department shall so certify to the contracting agency and such certification shall be binding upon the contracting agency unless it is reversed in the course of judicial review.

(2) If the contractor is found to have committed an unlawful practice under KRS 45.560 to 45.640, the contracting agency may cancel or terminate the contract, conditioned upon a program for future compliance approved by the contracting agency and the department. The contracting agency may declare such a contractor ineligible to bid on further contracts with that agency until such time

as the contractor complies in full with the requirements of KRS 45.560 to 45.640.

(3) The equal employment provisions of KRS 45.560 to 45.640 may be met in part by a contractor by subcontracting to a minority contractor or subcontractor. For the provisions of KRS 45.560 to 45.640, a minority contractor or subcontractor shall mean a business that is owned and controlled by one or more persons disadvantaged by racial or ethnic circumstances.

KRS 45.630 Termination of existing employee not required, when

Any provision of KRS 45.560 to 45.640 notwithstanding, no contractor shall be required to terminate an existing employee upon proof that employee was employed prior to the date of the contract.

KRS 45.640 Minimum skills

Nothing in KRS 45.560 to 45.640 shall require a contractor to hire anyone who fails to demonstrate the minimum skills required to perform a particular job."

It is recommended that all of the provisions above quoted be included as special conditions in each contract. In the case of a contract exceeding \$250,000, the contractor is required to furnish evidence that his workforce in Kentucky is representative of the available work-force in the area from which he draws employees, or to supply an Affirmative Action plan which will achieve such representation during the life of the contract.

LFUCG Non-Appropriation Clause

Contractor acknowledges that the LFUCG is a governmental entity, and the contract validity is based upon the availability of public funding under the authority of its statutory mandate.

In the event that public funds are unavailable and not appropriated for the performance of the LFUCG's obligations under this contract, then this contract shall automatically expire without penalty to the LFUCG thirty (30) days after written notice to Contractor of the unavailability and non-appropriation of public funds. It is expressly agreed that the LFUCG shall not activate this non-appropriation provision for its convenience or to circumvent the requirements of this contract, but only as an emergency fiscal measure during a substantial fiscal crisis, which affects generally its governmental operations.

In the event of a change in the LFUCG's statutory authority, mandate and mandated functions, by state and federal legislative or regulatory action, which adversely affects the LFUCG's authority to continue its obligations under this contract, then this contract shall automatically terminate without penalty to the LFUCG upon written notice to Contractor of such limitation or change in the LFUCG's legal authority.

AFFIDAVIT

Comes the Affiant, Rebecca Self, and after being first duly sworn, states under penalty of perjury as follows:

1. His/her name is Rebecca Self and he/she is the individual submitting the proposal or is the authorized representative of FoodChain the entity submitting the proposal (hereinafter referred to as "Proposer").
2. Proposer will pay all taxes and fees, which are owed to the Lexington-Fayette Urban County Government at the time the proposal is submitted, prior to award of the contract and will maintain a "current" status in regard to those taxes and fees during the life of the contract.
3. Proposer will obtain a Lexington-Fayette Urban County Government business license, if applicable, prior to award of the contract.
4. Proposer has authorized the Division of Central Purchasing to verify the above-mentioned information with the Division of Revenue and to disclose to the Urban County Council that taxes and/or fees are delinquent or that a business license has not been obtained.
5. Proposer has not knowingly violated any provision of the campaign finance laws of the Commonwealth of Kentucky within the past five (5) years and the award of a contract to the Proposer will not violate any provision of the campaign finance laws of the Commonwealth.
6. Proposer has not knowingly violated any provision of Chapter 25 of the Lexington-Fayette Urban County Government Code of Ordinances, known as "Ethics Act."

7. Proposer acknowledges that "knowingly" for purposes of this Affidavit means, with respect to conduct or to circumstances described by a statute or ordinance defining an offense, that a person is aware or should have been aware that his conduct is of that nature or that the circumstance exists.

EQUAL OPPORTUNITY AGREEMENT

The Law

- Title VII of the Civil Rights Act of 1964 (amended 1972) states that it is unlawful for an employer to discriminate in employment because of race, color, religion, sex, age (40-70 years) or national origin.
- Executive Order No. 11246 on Nondiscrimination under Federal contract prohibits employment discrimination by contractor and sub-contractor doing business with the Federal Government or recipients of Federal funds. This order was later amended by Executive Order No. 11375 to prohibit discrimination on the basis of sex.
- Section 503 of the Rehabilitation Act of 1973 states:

The Contractor will not discriminate against any employee or applicant for employment because of physical or mental disability

- Section 2012 of the Vietnam Era Veterans Readjustment Act of 1973 requires Affirmative Action on behalf of disabled veterans and veterans of the Vietnam Era by contractors having Federal contracts.
- Section 206(A) of Executive Order 12086, Consolidation of Contract Compliance Functions for Equal Employment Opportunity, states:

The Secretary of Labor may investigate the employment practices of any Government contractor or sub-contractor to determine whether or not the contractual provisions specified in Section 202 of this order have been violated.

The Lexington-Fayette Urban County Government practices Equal Opportunity in recruiting, hiring and promoting. It is the Government's intent to affirmatively provide employment opportunities for those individuals who have previously not been allowed to enter into the mainstream of society. Because of its importance to the local Government, this policy carries the full endorsement of the Mayor, Commissioners, Directors and all supervisory personnel. In following this commitment to Equal Employment Opportunity and because the Government is the benefactor of the Federal funds, it is both against the Urban County Government policy and illegal for the Government to let contracts to companies which knowingly or unknowingly practice discrimination in their employment practices. Violation of the above mentioned ordinances may cause a contract to be canceled and the contractors may be declared ineligible for future consideration.

GENERAL PROVISIONS

1. Each Respondent shall comply with all Federal, State & Local regulations concerning this type of service or good.

The Respondent agrees to comply with all statutes, rules, and regulations governing safe and healthful working conditions, including the Occupational Health and Safety Act of 1970, 29 U.S.C. 650 *et seq.*, as amended, and KRS Chapter 338. The Respondent also agrees to notify the LFUCG in writing immediately upon detection of any unsafe and/or unhealthful working conditions at the job site. The Respondent agrees to indemnify, defend and hold the LFUCG harmless from all penalties, fines or other expenses arising out of the alleged violation of said laws.

2. Failure to submit ALL forms and information required in this RFP may be grounds for disqualification.

3. Addenda: All addenda, if any, shall be considered in making the proposal, and such addenda shall be made a part of this RFP. Before submitting a proposal, it is incumbent upon each proposer to be informed as to whether any addenda have been issued, and the failure to cover in the bid any such addenda may result in disqualification of that proposal.

4. Proposal Reservations: LFUCG reserves the right to reject any or all proposals, to award in whole or part, and to waive minor immaterial defects in proposals. LFUCG may consider any alternative proposal that meets its basic needs.

5. Liability: LFUCG is not responsible for any cost incurred by a Respondent in the preparation of proposals.

6. Changes/Alterations: Respondent may change or withdraw a proposal at

any time prior to the opening; however, no oral modifications will be allowed. Only letters, or other formal written requests for modifications or corrections of a previously submitted proposal which is addressed in the same manner as the proposal, and received by LFUCG prior to the scheduled closing time for receipt of proposals, will be accepted. The proposal, when opened, will then be corrected in accordance with such written request(s), provided that the written request is contained in a sealed envelope which is plainly marked "modifications of proposal".

7. **Clarification of Submittal:** LFUCG reserves the right to obtain clarification of any point in a bid or to obtain additional information from a Respondent.
8. **Bribery Clause:** By his/her signature on the bid, Respondent certifies that no employee of his/hers, any affiliate or Subcontractor, has bribed or attempted to bribe an officer or employee of the LFUCG.
9. **Additional Information:** While not necessary, the Respondent may include any product brochures, software documentation, sample reports, or other documentation that may assist LFUCG in better understanding and evaluating the Respondent's response. Additional documentation shall not serve as a substitute for other documentation which is required by this RFP to be submitted with the proposal.
10. **Ambiguity, Conflict or other Errors in RFP:** If a Respondent discovers any ambiguity, conflict, discrepancy, omission or other error in the RFP, it shall immediately notify LFUCG of such error in writing and request modification or clarification of the document if allowable by the LFUCG.
11. **Agreement to RFP Terms:** In submitting this proposal, the Respondent agrees that it has carefully examined the specifications and all provisions relating to the work to be done attached hereto and made part of this proposal. By acceptance of a Contract/Grant under this RFP, proposer states that it understands the meaning, intent and requirements of the RFP and agrees to the same. The successful Respondent shall warrant that it is familiar with and understands all provisions herein and shall warrant that it can comply with them. No additional compensation to Respondent shall be authorized for services or expenses reasonably covered under these provisions that the proposer omits from its Proposal.
12. **Cancellation:** If the services to be performed hereunder by the Respondent are not performed in an acceptable manner to the LFUCG, the LFUCG may cancel this contract for cause by providing written notice to the proposer, giving at least thirty (30) days notice of the proposed cancellation and the reasons for same. During that time period, the proposer may seek to bring the performance of services hereunder to a level that is acceptable to the LFUCG, and the LFUCG may rescind the

cancellation if such action is in its best interest.

A. Termination for Cause

- (1) LFUCG may terminate a contract because of the contractor's failure to perform its contractual duties
- (2) If a contractor is determined to be in default, LFUCG shall notify the contractor of the determination in writing, and may include a specified date by which the contractor shall cure the identified deficiencies. LFUCG may proceed with termination if the contractor fails to cure the deficiencies within the specified time.
- (3) A default in performance by a contractor for which a contract may be terminated shall include, but shall not necessarily be limited to:
 - (a) Failure to perform the contract according to its terms, conditions and specifications;
 - (b) Failure to make delivery within the time specified or according to a delivery schedule fixed by the contract;
 - (c) Late payment or nonpayment of bills for labor, materials, supplies, or equipment furnished in connection with a contract for construction services as evidenced by mechanics' liens filed pursuant to the provisions of KRS Chapter 376, or letters of indebtedness received from creditors by the purchasing agency;
 - (d) Failure to diligently advance the work under a contract for construction services;
 - (e) The filing of a bankruptcy petition by or against the contractor; or
 - (f) Actions that endanger the health, safety or welfare of the LFUCG or its citizens.

B. At Will Termination

Notwithstanding the above provisions, the LFUCG may terminate this contract at will in accordance with the law upon providing thirty (30) days written notice of that intent. Payment for services or goods received prior to termination shall be made by the LFUCG provided these goods or services were provided in a manner acceptable to the LFUCG. Payment for those goods and services shall not be unreasonably withheld.

13. **Assignment of Contract:** The contractor shall not assign or subcontract any portion of the Contract without the express written consent of LFUCG. Any

purported assignment or subcontract in violation hereof shall be void. No failure or delay by LFUCG in exercising any right, remedy, power or privilege under or in respect of this Contract shall affect the rights, remedies, powers or privileges of LFUCG hereunder or shall operate as a waiver thereof.
15. **Authority to do Business:** The Respondent must be a duly organized and authorized to do business under the laws of Kentucky. Respondent must be in good standing and have full legal capacity to provide the services specified under this Contract. All parties expressly consent to personal jurisdiction and venue in such Court for the limited and sole purpose of proceedings relating to this Contract or any rights or obligations arising thereunder. Service of process may be accomplished by following the procedures prescribed by law.
17. **Ability to Meet Obligations:** Respondent affirmatively states that there are no actions, suits or proceedings of any kind pending against Respondent or, to the knowledge of the Respondent, threatened against the Respondent before or by any court, governmental body or agency or other tribunal or authority which would, if adversely determined, have a materially adverse effect on the authority or ability of Respondent to perform its obligations under this Contract, or which question the legality, validity or enforceability hereof or thereof.

18. Contractor understands and agrees that its employees, agents, or subcontractors are not employees of LFUCG for any purpose whatsoever. Contractor is an independent contractor at all times during the performance of the services specified.
19. If any term or provision of this Contract shall be found to be illegal or unenforceable, the remainder of the contract shall remain in full force and such term or provision shall be deemed stricken.

5.1 Program Proposal & Design

5.1.1 Needs Statement—Purpose of the Program Proposal / Problem Statement

Some of Lexington's most vulnerable populations live in one of Lexington's 35 food deserts. Food deserts are geographic areas with a high poverty rate (20% or more), limited access to a grocery store and transportation, including personal vehicle ownership and reliable public transport options. Living in a food desert is statistically tied to long term diet related illness including hypertension, heart disease, and diabetes, even in young children. 1 in 5 of the residents of Lexington experience food insecurity.

FoodChain serves families living in CEP school districts (where free and reduced lunch eligibility is greater than 60%). Focus neighborhoods all have poverty rates over 20% (some as high as 47%), and demographics with high rates of BIPOC residents (ranging from 25% - 81% BIPOC, with an average of 52%).

Fresh foods are often in limited supply at food pantries and school systems, while many families have no way to get to these sites to access resources, limited as they are. Fresh food preparation requires more time and experience, making them an inconvenient or impossible choice for many families. Seedleaf is working to address these challenges by teaching families to grow their own food, and Glean Kentucky is redistributing surplus fresh food from retailers and farmers to food pantries. FoodChain's program will meet families where they are by providing home delivery of locally grown fresh fruits, vegetables, meat and dairy, with corresponding recipes and educational materials to empower families to gain fluency and familiarity with nutritious, accessible meals.

5.1.2 Service Delivery Model

From July through Thanksgiving (20 weeks), we will provide approximately 75 families (350 people, 200 of which are children) with Nourish Boxes weekly.

Each week, families will receive a Nourish Box on their doorstep, containing three components: (1) hot, scratch-made and ready-to-eat dinners for each member in the household (2) A sandwich "kit" with supplies for families to make their own sandwiches and some prepared sides and (3) A meal kit of ingredients for the family to produce 4 other meals (breakfast and dinner for 2 days), including proteins, dried goods, fresh produce, milk, eggs, etc. All of these components will be primarily locally-sourced items, as well as donated, gleaned, surplus, and lightly-processed perishable items. Educational materials will accompany the Nourish Box, including recipes, family activities, nutrition lessons, and more. By partnering with WIC and SNAP education, families will also learn ways they can use those benefits to access locally grown produce. FoodChain staff will collaborate with other education providers to create culturally relevant, and diverse recipes throughout the program, highlighting flavors that are representative of the populations accessing this resource.

Our boxes will help families overcome the financial, educational, and transportation-based barriers to fresh, local food outlined in 5.1.1. The boxes are free to the recipient, thus removing financial barriers. Transportation barriers are eliminated by doorstep delivery. Finally, the educational information will increase nutritional literacy and provide instructions on how to prepare the ingredients so that recipients develop a toolkit for future cooking.

5.1.3 Client Eligibility and Requirements

Just as with our current Nourish Lexington meals program, clients eligibility is determined through self-identified need, the only paperwork requested will be evaluative surveys to assess the effectiveness of the program. Families are not required to live in the designated Census Tracts identified in the Needs Statement above, however we will target these high needs areas through outreach to community centers and FCPS Family Resource Coordinators at these Census Tract Priority areas to identify families who would benefit from this program and may be unable to access other services.

5.1.4 Evidence-Based/Best Practice

Many school districts offered food boxes during the pandemic both for efficiency and nutritional benefit. One local example, Berea Kids Eat, a Summer Food Service Program and Child and Adult Care Food Program Sponsor, adapted their meal services to provide a similar program as the proposed Nourish Boxes: the Family Mealtime Kits. Their program, funded by USDA SFSP and foundations, provided families with meal kits, totaling 400,000 meals. Their grant report states: "Berea Kids Eat received a great deal of positive feedback from families. Many families shared that their children and teens tried forms of fresh produce and new grains for the first time, in part because they had a hand in the final product. Others expressed that by working together in the kitchen, family members opened conversations and connected more with each other." In addition to familial connections through food, the program in Berea also spent \$60,000 in locally grown and processed foods for their meal kits.

The cooking education portion of Nourish Boxes is also based on best practices developed across the country. Researchers have found that students' diets are directly impacted by their involvement in the preparation of the food. Programs like Share our Strength: Cooking Matters and the National Farm to School Initiative have therefore been promoting programs that teach families to cook at home, and two different studies in 2014 found that both adults and students show improved diets, positive food choices, food behaviors and health outcomes with hands-on food preparation.

5.2 Program Measures & Evaluation

5.2.1 Service Efficacy & Desired Outcomes

FoodChain’s Nourish Boxes will increase our recipients’ access to nutritious meals and knowledge on how to provide wholesome meals for their families. For the 4.5 month duration, we will provide 1 Nourish Box per 4 individuals in a family, aiming to feed 350 people 2.5 days worth of meals each week.

Our service philosophy is that we eliminate barriers to nutritious, local, and wholesome products for all kids and their guardians in Lexington. Goals will be set to increase consumption of locally grown produce, increase knowledge of cooking techniques and learn new ways to obtain affordable fresh produce in the future. We define success as continued consumption of the Nourish Boxes, including the preparation of meals with the kit and recipe items offered, with a target of 75% of the components to be consumed by recipients. This will be self-reported by clients and compiled via regular questionnaires which will also gather feedback on consumption and knowledge changes over time.

5.2.2 Client Empowerment & Community Impact

FoodChain’s services increase the amount of wholesome ingredients, especially locally-sourced fresh produce, that food insecure families can access and consume. Most immediately, these clients can gain more food security with regular access to high quality, nutritious meals. Recipients’ health and well-being will be improved through habitual consumption of nutritious foods due to education on how to prepare and affordably access produce options for our neighbors, reducing dependency on processed fast food and convenience food items.

Our program cultivates food literacy and kitchen confidence, empowering families to nourish themselves by utilizing wholesome ingredients while exploring their own personal food preferences. This knowledge includes life skills such as food safety and sanitation, that can be transferred into career paths and independent living, with potential benefits to youth’s psychosocial development.

Nourish Boxes connect local businesses and farms with families in Lexington and will increase revenues for those businesses. Local business resiliency improves job access in Lexington while fostering direct relationships to youth and families creates a cohesive community across diverse sectors.

5.2.3 Data Assessment & Quality Improvement

We will evaluate this program's efficacy with anonymous online and paper surveys, distributed with the Nourish Boxes once a month. Surveys will allow us to determine if they are enjoying the food provided, and solicit suggestions for alternatives or desired menus/ingredients to be included. We will conduct pre and post surveys to determine changes in dietary habits, including the frequency and number of servings that families consume of fresh fruits and vegetables. By surveying at regular intervals throughout the program, we will be able to determine if clients report increases in consumption habits, frequency of youth participation in cooking activities, and any self reported health, wellness, and positive psychosocial benefits.

Based on our current enrollment in the Nourish Meal Delivery program, we know that many families retain this service for the duration that it is offered, allowing us to track many of the same individuals over the entire 4.5 months. This will allow us to determine overall effectiveness in improving health, access to fresh foods, and increased food literacy.

Finally, we will record the number of meals served, geographic areas where food is provided, individuals who benefit, dollars spent with local food businesses and farms, and pounds of food dispersed.

Leandra Forman- Director of Operations - will coordinate this program, be the liaison with farmers, distributors, and donation sources to coordinate with the Kitchen Manager. She will submit the necessary reports on a quarterly basis. She has worked at FoodChain for 6 years and has successfully planned, prepared, executed, and evaluated many other programs.

Kristin Hughes - Education and Outreach Director - will coordinate the educational materials to accompany the boxes along with the survey instruments and analysis. She has worked at FoodChain for 2 years and was a classroom teacher for nearly a decade. She will submit reporting for the USDA's SFSP program to receive reimbursement for eligible youth meals.

Sarah Taylor - Mobile Meal Coordinator - will manage the delivery logistics of the Nourish Boxes and serve as the face of the program to our clients, setting up transportation routes and distributing survey materials. She will complete the necessary record keeping of Boxes distributed and households/individuals served each week.

Amber Lawrence - Kitchen Manager - will manage the schedule of the kitchen staff and manage the procurement, storage and organization of the necessary supplies for the boxes. They will set the menus, in collaboration with the education team and Operation Manager, and prioritize locally sourced, seasonal ingredients where possible.

5.3.2 Partnership & Resource Leverage

We partner both informally and formally with many of the local organizations already working in nutritious food access including Bluegrass Farm to Table, the Double Dollars program, Glean Kentucky, Farms to Food Banks, God's Pantry, Community Action Council, Lexington Leadership Foundation, Fayette County Health Department, Lexington Farmers Market, Fayette County Farm to School Council, Kentucky Dept of Ag, and FCPSFRCs. We have dedicated volunteers and interns that assist with educational outreach, our aquaponics farm, and deliver meals to those in need during the pandemic as part of our Nourish Lexington effort.

In addition to grant funding from past ESR programs and a CDBG, we also receive private funding from Traditional Bank, the William R Kenan, Jr Charitable Trust, the Murry Foundation, and individual donors. We are also the main financial recipient of the Nourish Fund at BGCF to help support wholesome meal access for families in need while supporting our local economy. Meals for youth are funded through the USDA Summer Food Program administered by the KY Dept of Education from June - Aug. We are in the final year of a four year Local Food Promotion Program Grant through the USDA, the scope of which falls directly in line with the programs outlined here. We have the continued fundraising support of our Board of Directors as well as established relationships with VisitLEX and Keeneland and strong ties to local farmers and chefs, including Ouita Michel and her family of restaurants.

5.3.3 Outreach & Inclusion Strategy

Families with limited transportation are often also those that have limited resources and lack convenient access to fresh food. By delivering Nourish Boxes directly to food insecure families, we ensure that transportation barriers do not negatively impact resident's ability to access quality food. We will work with school Family Resource Coordinators to prioritize families unable to access other services, including immigrant and minority communities, ensuring that the meals we provide are culturally appropriate and ethnically diverse. Our Education Director is fluent in Spanish and will provide educational materials and surveys in both English and Spanish. We also work with organizations and churches able to translate into the many other languages represented in Lexington.

Our program complies with recommendations from the Mayor's Commission on Racial Justice & Equity, especially through the Health Disparities Report. In Recommendation #2, our delivery method of Nourish Box distribution is a mobile food distribution, as explicitly recommended. This program increases food security for children and low income individuals by providing access to food and nutritional education in a method that supports locally grown produce, per the recommendations of the report. FoodChain has a proven track record in the community from our meal distribution the past year, building community trust and assurance that our programs are a reliable source of nutrition.

FoodChain affirms that fresh, wholesome food should not be out of reach for anyone, regardless of their income, race, ethnicity, ability, housing status, age, gender identity, or sexual orientation.
