THIS FIRST AMENDMENT TO PURCHASE OF SERVICE AGREEMENT (the "Amendment"), dated as of January 29, 2026, (the "Effective Date"), by and between **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, an urban county government of the Commonwealth of Kentucky created pursuant to KRS Chapter 67A (the "LFUCG"), located at 200 East Main Street, Lexington, Kentucky 40507, and **FOODCHAIN**, with offices located at 501 West Sixth Street, Suite 105, Lexington, Kentucky 40508 (hereinafter "Organization").

RECITALS

WHEREAS, LFUCG entered into a Purchase of Service Agreement with Organization, authorized pursuant to Resolution #412-2024, for the purchase of services related to the Extended Social Resource (ESR) Program (RFP #20-2024 - Food Insecurity and Nutritional Access); and

WHEREAS, the parties desire to amend the Agreement to authorize an additional allocation of funding for services provided pursuant to the Purchase of Service Agreement in FY 2026; and

WHEREAS, the Parties hereby agree to amend the above-referenced agreement in accordance with the terms and conditions of this First Amendment.

2. Additional Funding (FY2026). The Parties agree to modify Section 3 of the Purchase of Service Agreement to provide for an additional allocation of Twenty-Four Thousand and One Hundred and Eighty-Four Dollars (\$24,184.00) in Fiscal Year 2026, bringing the total allocation for Fiscal Year 2026 to (\$158,000.00). **The additional allocation shall be made available to Organization upon request.**
3. Effect. All other provisions of the Purchase of Service Agreement, which is attached hereto as Exhibit 1 and incorporated herein as if fully stated, not inconsistent with the provisions of this First Amendment shall remain in full force and effect.


