

ORDINANCE NO. 117 - 2025

AN ORDINANCE AMENDING THE AUTHORIZED STRENGTH BY ABOLISHING TWELVE (12) CLASSIFIED POSITIONS OF PARK MAINTENANCE SUPERVISOR, GRADE 517N, AND CREATING TWELVE (12) CLASSIFIED POSITIONS OF PARK MAINTENANCE SUPERVISOR, GRADE 518N, AND TRANSFERRING THE INCUMBENTS, ALL IN THE DIVISION OF PARKS AND RECREATION, EFFECTIVE THE FIRST PAY PERIOD FOLLOWING PASSAGE OF COUNCIL.
