**SUBJECT:** Notification of **Administrative Modification #19** to the FY 2021 – FY 2024 Transportation Improvement Program (TIP) and Administrative Modification #38 to the 2045 Metropolitan Transportation Plan (MTP)

On July 15, 2022, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #19 to the FY 2021 – 2024 TIP and Modification #38 to the 2045 MTP.

### **Administrative Modification #19:**

This action updates the previously published documents and tables. The modification updates the following project by moving funds from the Construction phase to the Right of Way phase:

- **Citation Trail – Section 2**
  - **Right of Way:** Increase from \$16,000 to \$31,400
    - \$25,120 (80% Federal STBG-TA funds) + \$6,280 (20% Local Match) = \$31,400
  - **Construction:** Decrease from \$632,000 to \$616,600
    - \$493,280 (80% Federal STBG-TA funds) + \$123,320 (20% Local Match) = \$123,320

The modification also adds the following KYTC Interstate resurfacing project:

- **I-75 Pavement – MP 97.95 – MP 107.445** (Kentucky River to approximately Man O' War Blvd - 9.59 miles)  
KYTC Item # 22116.00
  - **Construction:** \$10,380,150: \$9,342,135 (90% Federal NHPP funds) + \$1,038,015 (10% State Match)

Both projects are considered Grouped Projects\* (Pavement Resurfacing and Bike/Ped Facilities) which do not impact the financial constraint of the TIP.

*\* The identification of Grouped Projects involves a commitment of additional funding by the project sponsor. The additional funding maintains financial constraint of these documents. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP by Administrative Modification. TIP actions for these projects will not require additional public review, demonstration of fiscal constraint, or a conformity determination (if applicable).*
