## RELEASE OF EASEMENT

**WHEREAS**, Owner is the owner of certain real property located in Lexington, Fayette County, Kentucky, more particularly described as follows; and

It is the intention of the LFUCG to forever extinguish its easement interest in the area described above and on the attached Exhibits and the Owner, its successors and assigns forever, shall hereafter have and enjoy said property free and discharged from the interest of LFUCG. It is understood that in making this Release, the other easements and any portion thereof shown on the Plat and not described herein shall remain unaffected.




