

Banty Jones Park (Rome, GA): Landscape Architect for the complete renovation of a 5.25-acre park in an underserved community. Designed inclusive, accessible, and equitable play spaces, including a splash pad, separate play areas for ages 2-5 and 5+, and an active lawn. Developed community gathering areas with a stage, pavilions, and grilling zones. Incorporated all-native plantings and stormwater management improvements to enhance sustainability and ecological value. Led community branding and wayfinding improvements throughout the park, creating cohesive signage and design elements that reflect the local identity and enhance user experience.

George Pierce Park (Gwinnett County, GA): Design lead for an existing park expansion. New elements featured a universally accessible playground with seven unique play structures, including a two-story lookout tower with slides and climbing nets. Utilized a permeable rubber tile surfacing by sofSURFACES to promote stormwater infiltration, fall safety, and vibrant color coordination. The project also includes an accessible nature loop trail, designed with careful attention to minimize environmental impact while maintaining slopes under 5%. Low timber retaining walls preserved mature trees, and reforestation efforts, including the planting of 460 native trees, ensured a seamless integration with the surrounding landscape.

Sweetwater Creek Greenway and Club Drive Park (Gwinnett County, GA): Project Manager overseeing full landscape architecture services for Sweetwater Creek Greenway Phase I and Club Drive Park Phase II design and implementation. Led the project from initial fieldwork and base mapping to design development, including trail alignment, parcel crossing design, wetland delineation, and cost estimation.

Cherokee County Parks & Trails Southwest Area Plan (Cherokee County, GA): Landscape Designer for the development of a parks and trails master plan for the southwest region of the county, focusing on underutilized County-owned or leased parcels. 

SECTION 3: Project Understanding

Project Understanding

Veterans Park, a well-loved community space in Lexington, faces several challenges that need to be addressed to improve its functionality and user experience. One of the major issues is parking, especially during games and events. People often park on the grass despite efforts to discourage it, and the prohibition of street parking along the residential side of the street has not alleviated the problem. The two western fields closest to Southpoint Drive sit significantly higher up than the other two, leading to parking issues as people avoid hauling their chairs, wagons, and families up the hill.

Connectivity within the park is another challenge. The paths in and through the ballpark do not connect in an obvious way to the sidewalks along Southpoint or to the trail system within the park. This lack of connectivity makes it confusing for park users, especially those who feel like they are parking at a baseball complex. Additionally, the park's paths do not connect well to the surrounding sidewalks and trail system, and there is a need to improve ADA accessibility.



Parking and accessibility - much of the grassy area along St. Elias (Area I) is used as overflow parking for the baseball fields. This makes for accessibility challenges and is exacerbating issues of soil erosion between the upper and low ball fields as families routinely move between the batting cages and the ballfields.

SECTION 3: PROJECT UNDERSTANDING

Environmental considerations are also crucial, given the park's proximity to West Hickman Creek, which has undergone restoration. The park's lowlying field used by YMCA youth soccer teams and adult pickup leagues can often be soggy due to its proximity to the creek. Stormwater management is another concern, as the design team needs to identify existing stormwater features and assess the need for expansion based on the proposed changes.

Stakeholder engagement is essential for the success of this project, as several of the parking issues are driven by group and league activities. The design team will use small group interviews to gain a detailed understanding of the needs and challenges stakeholders face regularly.

While there is a major trailhead to the rest of Veterans Park within Area I there might be a perception that the parking and amenities around this area are reserved for baseball use.

EAST ROSWELL PARK

Roswell, GA

East Roswell Park, a popular 40-acre site, underwent significant renovations following an ADA assessment that identified areas for improvement. TSW was retained by the City of Roswell to lead the design and implementation of upgrades aimed at enhancing accessibility and inclusivity across the park.

Key features included the creation of a new 1-acre dog park, along with a paved entrance drive, lower parking lot, and a stormwater pond designed to meet current regulations and manage water quality and volume. The existing parking lot at the Art Center was reconfigured to include a turnaround and dropoff area, improving accessibility for parking and summer camp operations.

Additional improvements included the extension of 700 linear feet of multi-use trail to enhance park connectivity, ADA-compliant access at two pavilions, and the addition of an inclusive playground. Accessible parking and seating were also added at two multi-use fields.All new parking lots and drive aisles were designed to meet current ADA and fire accessibility codes.

During the design process, TSW provided cost estimates to coordinate with the client and ensure the project remained within budget.



SW Cherokee County Parks and Trails Plan

Cherokee County, GA



TSW was retained by Cherokee County to create a park and trails area plan for the SW portion of the county. The plan is intended to address parcels owned or leased by Cherokee County and intended for use as public parks and recreation facilities along with a system of trails and bike / ped facilities around the parks. The area encompasses about 6,000 acres, with geographic boundaries of the Bartow County line on the west side, Wade Green Road on the east, the Cobb County line to the south and near Kellogg Creek Road and the U.S. Army Corps of Engineers property on the north side.

With a robust virtual public input process, TSW worked with the County and community to listen to challenges and opportunities of the sites, help develop a vision for the park sites and trails, and gathered feedback on conceptual designs. Public input activities included: Stakeholder Interviews and Focus Groups, Online Surveys for each park and recreation habits in general, a virtual Kick-off Meeting, in-person Popup Event paired with a virtual Design Workshop, and culminated in a Draft Plan Review Meeting and Presentation to County Boards and Commissions. All through the process, virtual engagement methods allowed residents and park users to provide placebased feedback on interactive maps with the concept plan options.

TSW developed Conceptual Plans for the parks and trail system totaling 140 acres with a variety of passive and active programming and provided a minimum of two options per site to present to the community for feedback. Following final input, TSW revised concepts into a Preferred Concept Plan for each site that included Construction Cost Estimates and a Phased Capital Improvement Program.

LONG SWAMP CREEK RECREATION AREA

Located at 2015 Ball Ground Road, at the confluence of Long Swamp Creek and the Etowah River, this 24-acre park is located mostly in flood plain and has significant Native American history on the site. The master plan includes an outdoor archery range, canoe & kayak launch, primitive camping sites, trails, and picnic areas along with the necessary parking and restroom facilities to support the park.

The county has applied for a grant through the Georgia Outdoor Stewardship program managed by the GA Department of Natural Resources and expects to receive notice in fall of 2022 on the success of this application. Grant funds will be matched by Cherokee County Special Purpose Local Option Sales Tax (SPLOST) funds.

Yellow Creek Recreation Area

Yellow Creek Road Conservation Area & Trails will serve as a passive conservation park. The conservation area's size and drastic topography change provides various recreational and educational opportunities, and the conservation easement on the property limits what can be constructed. Public input indicated that equestrian and mountain biking trails were most desired in this location.

Woodworth Park

Intended to be both an active and passive park. Active areas will accommodate areas for play, splash pad and little league field sports. Passive elements of the park will include walking trails through the park, overlooks and a canopy walk. In the future, the site will also become the home of the Cherokee County Recreation and Community Center.

George Pierce Park Expansion

Gwinnett County, GA

George Pierce Park expansion is an intergenerational, universally-accessible park project. The 304-acre County Park includes a community center, sports fields, the Ivy Creek Trail, and expanses of high quality upland and lowland forest.

The centerpiece of TSW's plan for the park expansion is a universally-accessible playground embracing features that remove both the physical and social barriers to equitable play. In addition, an accessible nature loop trail was designed to traverse the rugged forest adjacent to the playground while maintaining slopes less than 5%. Design of the trail was challenging and required diligent focus before and during construction to minimize damage to the woodland floor and mature tree canopy. Prior to construction, the on-site review of the land disturbance yielded in-field changes to minimize the construction footprint. Low timber retaining walls were used to reduce grading and preserve trees allowing the path to stay tight to the existing topography and better engage the native landscape. The result is a pathway that appears as though it has been there for years. In areas where grading could not be minimized, reforestation techniques were utilized. More than 450 five-gallon trees, consisting of oaks, tulip poplars, hickories, and ironwoods were planted 6 feet on center to help quickly stitch gaps in the forest canopy.

Sweetwater Creek Greenway & Club Drive Park: Phase II

Lawrenceville, GA

TSW was retained as part of a multi-year on-demand landscape architecture services contract to provide full landscape architecture services for the Sweetwater Creek Greenway Phase I and Club Drive Park Phase II design and implementation. Sweetwater Creek Greenway totals approximately 5.5 miles and runs along Sweetwater Creek from Bethesda Park to Club Drive Park. TSW's portion of work includes two segment of approximately one mile, which is a combination of concrete trail and boardwalk sections over creeks and wetlands. The effort kicked off with fieldwork and base mapping followed by design work, which included trail alignment and plans, detailed parcel crossing design, wetland delineation, and cost estimates. The project is currently in the phases to develop RTP Grant exhibits, NEPA documentation, and a Flood Study. TSW will then develop construction documents, conduct permitting, assist with the bidding process, and provide construction administration services. The second phase of Club Drive Park, which opened in early 2019, includes two boardwalk structures with integrated seating and signage elements, which provide a unique experience of the surrounding woods and wetlands. A large lawn provides ample recreational space, and the outer circulation path connects with the trails in Phase I of the park to create a multi-use exercise loop. Estimated construction costs were approximately \$6 million.

Bowling Green Downtown Square Improvements Bowling Green, Kentucky

The City of Bowling Green set forth an unprecedented project need in their request for assistance with engineering, design, plan development, and construction management / inspection of these Downtown Square Improvements (12 square blocks). Areas of emphasis were identified to focus improvement efforts, including:

- \cdot The creation of safe pedestrian connections and amenities around Fountain Square Park
- · Improved connectivity between Fountain Square Park and Circus Square Park
- \cdot Safety, traffic, and operational evaluation of the one-way pair, College and State Streets
- Investment into Morris Alley and Capital Alley to provide safe connections from Fountain Square Park to parking

As part of the traffic and safety analysis, data was collected and evaluated around Fountain Square Park to prepare an existing/future traffic operations analysis. The results showed additional capacity above what would be needed in the future, resulting in the opportunity to make lane reductions, translating to more usable space for multimodal connections. **To address pedestrian safety issues, the lane reductions allowed for direct and defined connections to Fountain Square Park.** In addition, modified parking configurations were proposed to enhance sight distance.



Newtown Pike Design

Lexington, Kentucky

This urban roadway improvement project is located in Fayette County, along Newtown Pike (KY 922) between its intersections with W. Fourth Street and Loudon Avenue. The project includes approximately 2100 feet of urban widening along Newtown Pike, 1200 feet of urban widening along Loudon Avenue, and 1300 feet of widening along Georgetown Road/ W. Fourth Street. A 10 foot shared use path has been constructed along Newtown Pike and West Loudon Avenue. The path traverses through the campus property and connects to the Legacy Trail (a 12 mile walking and biking trail) at the entrance of the North Lexington YMCA. HMB designed a 112 foot pedestrian/ bicycle bridge to carry the path over an under pass that goes under West Loudon. HMB incorporated weathered steel into the design to match current structures along the Legacy Trail. Handicap ramps and detectable warnings, meeting the American Disabilities Act requirements, were added at all intersections and entrances.

Along with the challenging traffic numbers, above and below ground utilities and adjacent businesses, the new college campus provided significant challenges. HMB worked with District 7 to address these issues early in the project development stage and were able to minimize impacts and keep project costs manageable. Minimizing utility impacts and maintaining traffic through construction were both significant challenges on this project. HMB worked with District 7 team members in order to deliver a solution that minimized disruption to existing utilities and maintained traffic flow during construction.

KY 1681 Manchester Street Pedestrian Study Lexington, Kentucky

The Manchester Street Pedestrian Study was initiated in March 2024 by the Lexington-Fayette Urban County Government (LFUCG) to evaluate pedestrian activity along Manchester Street adjacent to the entertainment area, the Distillery District, to assess the need for and potential options for safer, more user-friendly access. The study area extends from the intersection of Manchester Street and South Forbes Road south to the existing pedestrian crossing at Thompson Road.

Tasks undertaken to assess pedestrian connectivity in this area include:


- Existing roadway information / geometrics / traffic volume / crash data
- Field review
- Informal interviews of stakeholders / business owners / coordination with KYTC
- On-site observations of pedestrian activity
- Research on applications of pedestrian accommodation in other entertainment venues
- Identification of pedestrian safety countermeasures
- High-level planning cost estimates
- Concept drawings with sight distance evaluation

A new mid-block crossing was identified as the top priority project connecting the rear parking lot of Goodfellas to Legacy Trail / parking.

Our team worked in conjunction with LFUCG and KYTC to evaluate key considerations for KYTC to consider a permit for a marked crosswalk include:

- Appropriate sight distance looking both ways on Manchester Street. This was evaluated and determined to meet requirements.
- A development plan for improvements to the parking area behind Goodfellas to allow for safe pedestrian passage from the crosswalk to the patio area.
- A connection on the parking lot side either to Town Branch Trail or to a new sidewalk.

Additional guidance documents was consulted to determine if treatments beyond pavement marking and signage would be required for installing a crosswalk at this location. According to the FHWA Guide for Improving Pedestrian Safety at Uncontrolled Crossing Locations matrix, high-visibility crosswalk markings, parking restrictions on crosswalk approaches, adequate nighttime lighting levels and crossing warning signs should be considered.

Project Approach

I. Phase I - Site Analysis + Planning

The design team will develop a site plan that responds to our comprehensive analysis of the existing physical conditions and an understanding of the needs and use patterns of current and proposed users and groups within the park.

1.1. Site Analysis:

The site analysis will focus on several key areas to ensure a comprehensive understanding of the park's current conditions, uses/users and potential improvements. The outcome of the analysis will identify the needs and drivers to inform the conceptual design. The site analysis will with the following areas:

- Parking Audit: Parking is a significant issue during games and events, with people often parking on the grass despite efforts to discourage it. Vehicular circulation through the existing parking lots is also challenged by dead end drive aisles and confusing flow. Safe pedestrian access within the parking lot, to the fields, and to the trailhead or playgrounds is also a major concern. The analysis will assess current parking facilities through discussions with user groups and through field surveys, and identify opportunities for expansion, with a focus on safety, accommodating peak capacity, and ADA accessibility compliance.
- 2. Geotechnical Investigation: The analysis will include a preliminary geotechnical investigation to understand the soil conditions, subsurface rock locations, and any potential challenges for construction and landscaping. The goal is to avoid areas that may be costly for building the expanded parking. Our study will identify areas for further geotechnical investigation to be provided by the City later in the process. Athena Engineering & Environmental, LLC brings extensive geotechnical engineering expertise to park and greenway projects, including being the geotechnical consultant for multiple A/E contracts with Metro Nashville Parks and Recreation. They regularly perform geotechnical studies for the design of new greenways, parking lots, pavilions, maintenance buildings, retaining

walls, event centers, and other structures related to existing and new park facilities. They will review the proposed site plan and develop a scope for the Owner to use in procuring a geotechnical investigation under a separate contract. Once completed, they will also review the geotechnical investigation report provided by the Owner and provide comments for the preparer and the design team.

SECTION 5: PROJECT APPROACH

- 3. **Connectivity and ADA Accessibility:** The paths within the park do not connect well to the park facilities, surrounding sidewalks and trail system. The analysis will explore ways to improve connectivity and make the park more accessible to all users. Where possible, the design team will strive to make all areas universally accessible while also minimizing the use of ramps and stairs.
- 4. **Environmental Considerations:** The park is located near West Hickman Creek, which has undergone restoration. The analysis will consider the environmental impact of any proposed changes and ensure that the natural plantings and creek restoration efforts are preserved.
- 5. **Stormwater Analysis:** The design team will identify existing stormwater features and assess the need for expansion based on the proposed changes.
- 6. **Stakeholder Engagement:** Engaging the stakeholder groups is crucial for the success of this project given that several of the parking issues are driven by group/league activities. The design team will use small group interviews to gain a detailed understanding of the needs and challenges stakeholders deal with on a regular basis. This would likely include representatives of the various baseball leagues, and the Pinnacle and Waterford Neighborhood Associations. We would leverage existing contacts from the recently constructed dog park which included the Kentucky Mountain Bike Association and the Hickman Creek Conservancy. As an additional service, our analysis can include a community engagement workshop to gather input on programming needs from the community at large.

1.2. Conceptual Design:

A conceptual design will be developed to address the needs and issues identified in the site analysis and enhance the park's functionality and user experience. The plan will balance need and cost to develop appropriate parking and connectivity to park areas 1 and 2. The RFP identified specific criteria for connectivity to these areas:

- 1. Area 1: Trail option 1 to include a new walking path or shared use trail connection from Southpoint Lane along the entrance road to the stop sign below the baseball fields and existing parking.
- 2. Area 2: Trail Option 2 to include a new shared -use trail connection from Southpoint Ln along/adjacent to the current multi-use field space to connect to the existing trail by play elements. The existing trail may also need to be widened to be at the last 12 feet wide to match the proposed new trail.



The internal park trail network currently ends at the multi-use fields and lacks a needed connection to Southpoint Drive. This area of the park feels disconnected due to these circulation challenges.

SECTION 5: PROJECT APPROACH

1.3. Schematic Plans + Cost Estimate:

Schematic Plans: The design team will develop schematic plans that apply the conceptual design framework and program in detail to the site. This will include scaled schematic plan layouts, conceptual grading (including stormwater), supporting imagery, materiality, and sketches, to communicate design ideas. The plans will address areas specifically referenced in the RFP:

- 1. New parking area(s) with ADA accessibility and path of travel and with sufficient stormwater management while managing floodplain impacts. Recommend any necessary repair or replacement of existing retaining wall below baseball field in conjunction with new wall alignment to accommodate parking design.
- 2. Trail Option 1
- 3. Trail Option 2

Cost Estimate: A detailed cost estimate will be prepared to provide a preliminary evaluation of the general magnitude of the costs associated with the project including the 3 areas identified in the RFP. This will include estimates for materials based on construction types and other necessary details.

II. Phase II – Community Input + Construction Documentation

2.1. Community Engagement:

The design team will lead one 2 hour community engagement workshop to gather community input on the proposed plans. The city will provide a meeting space and advertise the workshop to the public.

Optional engagement opportunities could be added onto the scope for a nominal fee including:

- Pop-Ups and surveying of users at baseball games and sports practices in the meadow, weekends in the park, at Pinnacle or Waterford food truck meets, at the dog park or disc golf courses.
- Online survey with flyers distributed at baseball games, and yard signs posted at trailheads and park entrances with QR codes.
- Mailings to surrounding neighbors.

2.2. Construction Documents:

Detailed construction documents will be prepared to guide the implementation of the proposed design. These documents will include specifications for materials, dimensions, and other necessary details. Work in this phase shall include meetings with all regulatory agencies required to obtain approval of the construction documents prior to bid (if applicable). Parks and Recreation, in conjunction with the Division of Purchasing, will provide all sections of the bid specifications (General Conditions, Labor, etc.) needed for public bid. All technical specifications shall be provided by the Consultant. The Consultant will attend the pre-bid meeting, assist the Owner in responding to questions during bidding and help evaluate the bids received.

Permitting will be led by HMB's environmental staff who offer extensive experience completing field surveys, document preparation, and regulatory agency coordination. A preliminary review of the project area identified West Hickman Creek along the southern edge of the Area 1. As the project moves forward, HMB will document all water related resources and work closely with the design team to avoid impacts as much as possible. When impacts are unavoidable, we will aim to minimize or mitigate them, and then work with the regulatory agencies to obtain the necessary permits.

The bidder (hereafter "bidder," or "contractor") agrees and understands that in addition to all conditions stated within the attached bid documents, the following conditions will also apply to any Agreement entered between bidder and LFUCG, if LFUCG uses Federal funds, including but not limited to funding received by LFUCG under the American Rescue Plan Act ("ARPA"), toward payment of goods and/or services referenced in this bid. The bidder also agrees and understands that if there is a conflict between the terms included elsewhere in this Request for Proposal and the terms of this Amendment 1, then the terms of Amendment 1 shall control. The bidder further certifies that it can and will comply with these conditions, if this bid is accepted and an Agreement is executed:

1. Any Agreement executed as a result of acceptance of this bid may be governed in accordance with 2 CFR Part 200 and all other applicable Federal law and regulations and guidance issued by the U.S. Department of the Treasury.

2. Pursuant to 24 CFR § 85.43, any Agreement executed as a result of acceptance of this bid can be terminated if the contractor fails to comply with any term of the award. This Agreement may be terminated for convenience in accordance with 24 CFR § 85.44 upon written notice by LFUCG. Either party may terminate this Agreement with thirty (30) days written notice to the other party, in which case the Agreement shall terminate on the thirtieth day. In the event of termination, the contractor shall be entitled to that portion of total compensation due under this Agreement as the services rendered bears to the services required. However, if LFUCG suspects a breach of the terms of the Agreement and/or that the contractor is violating the terms of any applicable law governing the use of Federal funds, LFUCG may suspend the contractor's ability to receive payment by giving thirty (30) days' advance written notice. Further, either party may terminate this Agreement for cause shown with thirty (30) days written notice, which shall explain the party's cause for the termination. If the parties do not reach a settlement before the end of the 30 days, then the Agreement shall terminate on the thirtieth day. In the event of a breach, LFUCG reserves the right to pursue any and all applicable legal, equitable, and/or administrative remedies against the contractor.

3. The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, sexual orientation, gender identity, or national origin. The contractor will take affirmative action to ensure that applicants are employed and that employees are treated during employment without regard to their race, color, religion, sex, sexual orientation, gender identity, or national origin. Such action shall include, but not be limited to the following:

(1) Employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided setting forth the provisions of this nondiscrimination clause.

(2) The contractor will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, sexual orientation, gender identity, or national origin. (3) The contractor will not discharge or in any other manner discriminate against any employee or applicant for employment because such employee or applicant has inquired about, discussed, or disclosed the compensation of the employee or applicant or another employee or applicant. (4) The contractor will send to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding a notice to be provided advising the said labor union or workers' representatives of the contractor's commitments under this section and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

(5) The contractor will comply with all provisions of Executive Order 11246 of September 24, 1965, and of the rules, regulations, and relevant orders of the Secretary of Labor.

(6) The contractor will furnish all information and reports required by Executive Order 11246 of September 24, 1965, and by rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will permit access to his books, records, and accounts by the administering agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.

(7) In the event of the contractor's noncompliance with the nondiscrimination clauses of this contract or with any of the said rules, regulations, or orders, this contract may be canceled, terminated, or suspended in whole or in part, and the contractor may be declared ineligible for further government contracts or federally assisted construction contracts in accordance with procedures authorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.

(8) The contractor will include the portion of the sentence immediately preceding paragraph (1) and the provisions of paragraphs (1) through (8) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. The contractor will take such action with respect to any subcontract or purchase order as the administering agency may direct as a means of enforcing such provisions, including sanctions for noncompliance.

Provided, however, that in the event a contractor becomes involved in or is threatened with litigation with a subcontractor or vendor as a result of such direction by the administering agency, the contractor may request the United States to enter into such litigation to protect the interests of the United States.

4. If fulfillment of the contract requires the contractor to employ mechanic's or laborers, the contractor further agrees that it can and will comply with the following:

6. The contractor shall report each violation to LFUCG and understands and agrees that LFUCG will, in turn, report each violation as required to assure notification to the Treasury Department and the appropriate Environmental Protection Agency Regional Office.

7. The contractor shall include these requirements in numerical paragraphs 5 and 6 in each subcontract exceeding \$100,000 financed in whole or in part with Federal funding.

8. The contractor shall comply with all applicable standards, orders, or regulations issued pursuant to the Federal Water Pollution Control Act, as amended, 33 U.S.C. § 1251 et seq.

9. The contractor shall report each violation to LFUCG and understands and agrees that LFUCG will, in turn, report each violation as required to assure notification to the Treasury Department and the appropriate Environmental Protection Agency Regional Office.

10. The contractor shall include these requirements in numerical paragraphs 8 and 9 in each subcontract exceeding \$100,000 financed in whole or in part with Federal funds.

11. The contractor shall comply with all applicable standards, orders, or regulations issued pursuant to the Federal Water Pollution Control Act, as amended, 33 U.S.C. § 1251 et seq.

12. The contractor shall report each violation to LFUCG and understands and agrees that LFUCG will, in turn, report each violation as required to assure notification to the Treasury Department and the appropriate Environmental Protection Agency regional office.

13. The contractor shall include these requirements in numerical paragraphs 11 and 12 in each subcontract exceeding \$100,000 financed in whole or in part with American Rescue Plan Act funds.

14. The contractor shall include this language in any subcontract it executes to fulfill the terms of this bid: "the sub-grantee, contractor, subcontractor, successor, transferee, and assignee shall comply with Title VI of the Civil Rights Act of 1964, which prohibits recipients of federal financial assistance from excluding from a program or activity, denying benefits of, or otherwise

discriminating against a person on the basis of race, color, or national origin (42 U.S.C. § 2000d et seq.), as implemented by the Department of the Treasury's Title VI regulations, 31 CFR Part 22, which are herein incorporated by reference and made a part of this contract (or agreement). The Respondent agrees to indemnify, defend and hold the LFUCG harmless from all penalties, fines or other expenses arising out of the alleged violation of said laws.

- 2. Failure to submit ALL forms and information required in this RFP may be grounds for disqualification.
- 3. Addenda: All addenda and IonWave Q&A, if any, shall be considered in making the proposal, and such addenda shall be made a part of this RFP. - 7. Clarification of Submittal: LFUCG reserves the right to obtain clarification of any point in a bid or to obtain additional information from a Respondent.
- 8. Bribery Clause: By his/her signature on the bid, Respondent certifies that no employee of his/hers, any affiliate or Subcontractor, has bribed or attempted to bribe an officer or employee of the LFUCG.

- 9. Additional Information: While not necessary, the Respondent may include any product brochures, software documentation, sample reports, or other documentation that may assist LFUCG in better understanding and evaluating the Respondent's response. Additional documentation shall not serve as a substitute for other documentation which is required by this RFP to be submitted with the proposal,
- 10. Ambiguity, Conflict or other Errors in RFP: If a Respondent discovers any ambiguity, conflict, discrepancy, omission or other error in the RFP, it shall immediately notify LFUCG of such error in writing and request modification or clarification of the document if allowable by the LFUCG.
- 11. Agreement to Bid Terms: In submitting this proposal, the Respondent agrees that it has carefully examined the specifications and all provisions relating to the work to be done attached hereto and made part of this proposal. By acceptance of a Contract under this RFP, proposer states that it understands the meaning, intent and requirements of the RFP and agrees to the same. The successful Respondent shall warrant that it is familiar with and understands all provisions herein and shall warrant that it can comply with them. No additional compensation to Respondent shall be authorized for services or expenses reasonably covered under these provisions that the proposer omits from its Proposal.
- 12. Cancellation: If the services to be performed hereunder by the Respondent are not performed in an acceptable manner to the LFUCG, the LFUCG may cancel this contract for cause by providing written notice to the proposer, giving at least thirty (30) days notice of the proposed cancellation and the reasons for same. During that time period, the proposer may seek to bring the performance of services hereunder to a level that is acceptable to the LFUCG, and the LFUCG may rescind the cancellation if such action is in its best interest.

A. Termination for Cause

- (1) LFUCG may terminate a contract because of the contractor's failure to perform its contractual duties
- (2) If a contractor is determined to be in default, LFUCG shall notify the contractor of the determination in writing, and may include a specified date by which the contractor shall cure the identified deficiencies. LFUCG may proceed with termination if the contractor fails to cure the deficiencies within the specified time.

B. At Will Termination

- 15. Authority to do Business: The Respondent must be a duly organized and authorized to do business under the laws of Kentucky. Respondent must be in good standing and have full legal capacity to provide the services specified under this Contract. The Respondent must have all necessary right and lawful authority to enter into this Contract for the full term hereof and that proper corporate or other action has been duly taken authorizing the Respondent to enter into this Contract. GENERAL PROVISIONS

1. Each Respondent shall comply with all Federal, State & Local regulations concerning this type of service or good.

The Respondent agrees to comply with all statutes, rules, and regulations governing safe and healthful working conditions, including the Occupational Health and Safety Act of 1970, *29 U.S.C. 650 et. seq.*, as amended, and KRS Chapter 338. The Respondent also agrees to notify the LFUCG in writing immediately upon detection of any unsafe and/or unhealthful working conditions at the job site. The Respondent agrees to indemnify, defend and hold the LFUCG harmless from all penalties, fines or other expenses arising out of the alleged violation of said laws.

- 2. Failure to submit ALL forms and information required in this RFP may be grounds for disqualification.
- 3. Addenda: All addenda and IonWave Q&A, if any, shall be considered in making the proposal, and such addenda shall be made a part of this RFP. Before submitting a proposal, it is incumbent upon each proposer to be informed as to whether any addenda have been issued, and the failure to cover in the bid any such addenda may result in disqualification of that proposal.
- 4. Proposal Reservations: LFUCG reserves the right to reject any or all proposals, to award in whole or part, and to waive minor immaterial defects in proposals. LFUCG may consider any alternative proposal that meets its basic needs.
- 5. Liability: LFUCG is not responsible for any cost incurred by a Respondent in the preparation of proposals.
- 6. Changes/Alterations: Respondent may change or withdraw a proposal at any time prior to the opening; however, no oral modifications will be allowed. Only letters, or other formal written requests for modifications or corrections of a previously submitted proposal which is addressed in the same manner as the proposal, and received by LFUCG prior to the scheduled closing time for receipt of proposals, will be accepted. The proposal, when opened, will then be corrected in accordance with such written request(s), provided that the written request is contained in a sealed envelope which is plainly marked "modifications of proposal".
- 7. Clarification of Submittal: LFUCG reserves the right to obtain clarification of any point in a bid or to obtain additional information from a Respondent.
- 8. Bribery Clause: By his/her signature on the bid, Respondent certifies that no employee of his/hers, any affiliate or Subcontractor, has bribed or attempted to bribe an officer or employee of the LFUCG.

- 9. Additional Information: While not necessary, the Respondent may include any product brochures, software documentation, sample reports, or other documentation that may assist LFUCG in better understanding and evaluating the Respondent's response. Additional documentation shall not serve as a substitute for other documentation which is required by this RFP to be submitted with the proposal,
- 10. Ambiguity, Conflict or other Errors in RFP: If a Respondent discovers any ambiguity, conflict, discrepancy, omission or other error in the RFP, it shall immediately notify LFUCG of such error in writing and request modification or clarification of the document if allowable by the LFUCG.
- 11. Agreement to Bid Terms: In submitting this proposal, the Respondent agrees that it has carefully examined the specifications and all provisions relating to the work to be done attached hereto and made part of this proposal. By acceptance of a Contract under this RFP, proposer states that it understands the meaning, intent and requirements of the RFP and agrees to the same. The successful Respondent shall warrant that it is familiar with and understands all provisions herein and shall warrant that it can comply with them. No additional compensation to Respondent shall be authorized for services or expenses reasonably covered under these provisions that the proposer omits from its Proposal.
- 12. Cancellation: If the services to be performed hereunder by the Respondent are not performed in an acceptable manner to the LFUCG, the LFUCG may cancel this contract for cause by providing written notice to the proposer, giving at least thirty (30) days notice of the proposed cancellation and the reasons for same. During that time period, the proposer may seek to bring the performance of services hereunder to a level that is acceptable to the LFUCG, and the LFUCG may rescind the cancellation if such action is in its best interest.

A. Termination for Cause

- (1) LFUCG may terminate a contract because of the contractor's failure to perform its contractual duties
- (2) If a contractor is determined to be in default, LFUCG shall notify the contractor of the determination in writing, and may include a specified date by which the contractor shall cure the identified deficiencies. LFUCG may proceed with termination if the contractor fails to cure the deficiencies within the specified time.
- (3) A default in performance by a contractor for which a contract may be terminated shall include, but shall not necessarily be limited to:
 - (a) Failure to perform the contract according to its terms, conditions and specifications;
 - (b) Failure to make delivery within the time specified or according

to a delivery schedule fixed by the contract;

- (c) Late payment or nonpayment of bills for labor, materials, supplies, or equipment furnished in connection with a contract for construction services as evidenced by mechanics' liens filed pursuant to the provisions of KRS Chapter 376, or letters of indebtedness received from creditors by the purchasing agency;
- (d) Failure to diligently advance the work under a contract for construction services;
- (e) The filing of a bankruptcy petition by or against the contractor; or
- (f) Actions that endanger the health, safely or welfare of the LFUCG or its citizens.

B. At Will Termination

Notwithstanding the above provisions, the LFUCG may terminate this contract at will in accordance with the law upon providing thirty (30) days written notice of that intent, Payment for services or goods received prior to termination shall be made by the LFUCG provided these goods or services were provided in a manner acceptable to the LFUCG. Payment for those goods and services shall not be unreasonably withheld.

- 13. Assignment of Contract: The contractor shall not assign or subcontract any portion of the Contract without the express written consent of LFUCG. Any purported assignment or subcontract in violation hereof shall be void. It is expressly acknowledged that LFUCG shall never be required or obligated to consent to any request for assignment or subcontract; and further that such refusal to consent can be for any or no reason, fully within the sole discretion of LFUCG.
- 14. No Waiver: No failure or delay by LFUCG in exercising any right, remedy, power or privilege hereunder, nor any single or partial exercise thereof, nor the exercise of any other right, remedy, power or privilege shall operate as a waiver hereof or thereof. No failure or delay by LFUCG in exercising any right, remedy, power or privilege under or in respect of this Contract shall affect the rights, remedies, powers or privileges of LFUCG hereunder or shall operate as a waiver thereof.
- 15. Authority to do Business: The Respondent must be a duly organized and authorized to do business under the laws of Kentucky. Respondent must be in good standing and have full legal capacity to provide the services specified under this Contract. The Respondent must have all necessary right and lawful authority to enter into this Contract for the full term hereof and that proper corporate or other action has been duly taken authorizing the Respondent to enter into this Contract. The Respondent will provide LFUCG with a copy of a corporate resolution authorizing this action and a letter from an attorney confirming that the proposer is authorized to do business in the State of Kentucky if requested. All proposals must

be signed by a duly authorized officer, agent or employee of the Respondent.

- 16. Governing Law: This Contract shall be governed by and construed in accordance with the laws of the Commonwealth of Kentucky. In the event of any proceedings regarding this Contract, the Parties agree that the venue shall be the Fayette County Circuit Court or the U.S. District Court for the Eastern District of Kentucky, Lexington Division. All parties expressly consent to personal jurisdiction and venue in such Court for the limited and sole purpose of proceedings relating to this Contract or any rights or obligations arising thereunder. Service of process may be accomplished by following the procedures prescribed by law.
- 17. Ability to Meet Obligations: Respondent affirmatively states that there are no actions, suits or proceedings of any kind pending against Respondent or, to the knowledge of the Respondent, threatened against the Respondent before or by any court, governmental body or agency or other tribunal or authority which would, if adversely determined, have a materially adverse effect on the authority or ability of Respondent to perform its obligations under this Contract, or which question the legality, validity or enforceability hereof or thereof.
- 18. Contractor understands and agrees that its employees, agents, or subcontractors are not employees of LFUCG for any purpose whatsoever. Contractor is an independent contractor at all times during the performance of the services specified.
- 19. If any term or provision of this Contract shall be found to be illegal or unenforceable, the remainder of the contract shall remain in full force and such term or provision shall be deemed stricken.
- 20. Contractor [or Vendor or Vendor's Employees] will not appropriate or make use of the Lexington-Fayette Urban County Government (LFUCG) name or any of its trade or service marks or property (including but not limited to any logo or seal), in any promotion, endorsement, advertisement, testimonial or similar use without the prior written consent of the government. If such consent is granted LFUCG reserves the unilateral right, in its sole discretion, to immediately terminate and revoke such use for any reason whatsoever. Contractor agrees that it shall cease and desist from any unauthorized use immediately upon being notified by LFUCG.
