

AN ORDINANCE AMENDING CERTAIN OF THE BUDGETS OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT TO REFLECT CURRENT REQUIREMENTS FOR FUNDS IN THE AMOUNT OF \$1,500.00 FOR THE DIVISION OF PARKS AND RECREATION FROM NEIGHBORHOOD DEVELOPMENT FUNDS FOR THE PURCHASE OF EXERCISE EQUIPMENT FOR THE KENWICK COMMUNITY CENTER, AND APPROPRIATING AND RE-APPROPRIATING FUNDS, SCHEDULE NO. 0067.

WHEREAS, it is necessary and proper to amend the budgets of the Lexington-Fayette Urban County Government to reflect current requirements for the Division of Parks and Recreation for funds in the amount of \$1,500.00 from Neighborhood Development Funds for the purchase of exercise equipment for the Kenwick Community Center:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 - That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for the Division of Parks and Recreation for funds in the amount of \$1,500.00 from Neighborhood Development Funds for the purchase of exercise equipment for the Kenwick Community Center and that to effect such Amendments the following appropriations be and hereby are authorized and directed:


) Re-appropriations within the General Services District – General Fund which do not result in changes to the Unappropriated Fund Balance of these respective funds.


