

COMMUNITY PROJECT AGREEMENT

THIS COMMUNITY PROJECT AGREEMENT (“Agreement”), is made and entered into on the 10th day of February 2023, by and between the **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, an urban county government of the COMMONWEALTH OF KENTUCKY created pursuant to KRS Chapter 67A (“LFUCG”), 200 East Main Street, Lexington, Kentucky 40507, and **UNITED WAY OF THE BLUEGRASS**, a Kentucky nonprofit corporation, (“Organization”) with offices located at 651 Perimeter Drive, Suite 510, Lexington, Kentucky 40517.

WITNESSETH

WHEREAS, the Organization is a 501(c)(3) nonprofit organization, as defined by the Internal Revenue Code, and is in partnership with LFUCG for redevelopment of city-owned property located at 400 East Fifth Street (also known as the former Palmer Pharmacy Building);

WHEREAS, the Organization provides aide to residents of Fayette County who are low-income, underserved, and/or marginalized;

WHEREAS, LFUCG issued Request for Proposal (RFP) No. 24-2022 for its “Nonprofit Capital Grants Program,” which offers grant awards to Fayette County 501(c)(3) nonprofit organizations in recognition of the negative economic impacts of COVID-19 upon the local network of community agency partners;

WHEREAS, the Organization submitted a response to RFP No. 24-2022 seeking funding from LFUCG for operational costs related to redeveloping the Property into a “Waypoint Center,” so that it can continue providing needed services to Fayette County residents;

WHEREAS, the Organization and LFUCG have tentatively reached agreement for Organization to take ownership of the Property from LFUCG to further aide in its mission;

WHEREAS, LFUCG intends to fund projects, to hopefully lessen the economic impact of the COVID-19 pandemic on those Fayette County residents served by the Organization using revenue replacement funding derived from the American Rescue Plan Act of 2021 (ARPA);

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth herein, the receipt and sufficiency of which are acknowledged, the parties hereby agree as follows:

1. EFFECTIVE DATE; TERM. This Agreement shall commence on March 1, 2023, or upon the date all contingencies to this Agreement, which are stated in this numbered paragraph, have been fully satisfied, whichever date comes later. This Agreement shall last until December 31, 2026, unless terminated by LFUCG at an earlier time. The Agreement is contingent upon the Organization: 1) obtaining full control of the Property, 2) after the transfer of ownership of the Property is consummated, and 3) the Organization fully complying with each and every terms of its agreement with LFUCG related to the transfer of the Property.

2. **RELATED DOCUMENTS.** This Agreement shall consist of the terms herein as well as the following additional documents, which are attached hereto as exhibits and incorporated herein by reference as if fully stated:

- A. **Exhibit "A"** – Request for Proposal, Risk Management Provisions, and Scope of Project
- B. **Exhibit "B"** – Response to Request for Proposal

To the extent that there is any conflict between or among any of these documents, the terms and provisions of this Agreement shall prevail, followed by terms and provisions of **Exhibit "A"**, then **Exhibit "B"**, in that order.

3. **SCOPE OF WORK.** Organization shall complete the Scope of Project outlined in the attached **Exhibit "A"** (the "Project(s)"), as further specified in Numbered Paragraph 4 of this Agreement. The Organization shall complete these Projects in a timely, workmanlike and professional manner, as specified herein.

4. **PAYMENT.** LFUCG shall pay Organization a total amount not to exceed **TWO HUNDRED FORTY EIGHT THOUSAND ONE HUNDRED SIX DOLLARS AND 00/100 (\$248,106.00)** ("Funds") for the operational costs associated with redeveloping the Property into a Waypoint Center. The uses of the Funds are limited to this Project and may not be spent by the Organization for any other purpose without the prior written consent of LFUCG. Absent any additional written agreement stating otherwise, any travel or other expenses are excluded from the above payment schedule.

- A. LFUCG shall make payment under this Agreement upon timely submission of an invoice(s) from Organization specifying that nature of work performed, accompanied by data satisfactory to LFUCG to document entitlement to payment for work completed to date. LFUCG shall have thirty (30) days from the date of receipt of the invoice to pay the invoice amount. LFUCG reserves the right to refuse payment if it is determined by LFUCG that any of the work performed on the Projects is inadequate or defective.
- B. LFUCG also reserves the right to reject any invoice submitted for services more than sixty (60) days after the services were rendered.

5. **FEDERAL LAW.** The Organization understands that the Funds paid by LFUCG were awarded under the American Rescue Plan Act of 2021 ("ARPA"). Organization agrees to comply with any requests from LFUCG related to LFUCG's ongoing monitoring and reporting obligations set by federal law. Organization understands that the failure to comply may result in termination of this Agreement. Organization further agrees and by entering this Agreement, it hereby certifies to its ability to comply with all terms included within **Exhibits "A" and "B"** and also to the following terms, to the extent these terms are applicable to the subject matter of this Agreement as defined by applicable federal law:

- A. The Organization acknowledges and certifies that it has not been debarred or

suspended and further acknowledges and agrees that it must comply with regulations regarding debarred or suspended entities in accordance with 24 CFR § 570.489(l). Funds may not be provided to excluded or disqualified persons.

- B. The Organization agrees and certifies that to the greatest extent practicable, it will prefer the purchase, acquisition, and use of goods, products or materials produced in the United States, in conformity with 2 C.F.R. § 200.322.
- C. The Organization agrees and certifies that all activities performed pursuant to any agreement entered as a result of a contractor's bid, and all goods and services procured under that agreement, shall comply with 2 C.F.R. § 200.216 (Prohibition on certain telecommunications and video surveillance services and equipment) and 2 C.F.R. 200 § 200.323 (Procurement of recovered materials), to the extent either section is applicable.

6. **TERMINATION.** LFUCG, through the Mayor or the Mayor's designee, may terminate this Agreement for any reason whatsoever by providing Organization with at least thirty (30) days advance written notice. Organization shall be entitled for payment of all work performed up to that period of time, calculated on a reasonable basis.

- A. In the event of a termination based upon a material condition of non-performance or default by Organization, LFUCG shall provide Organization with advance written notice and a reasonable period of time to cure the breach.
- B. Organization may only terminate this Agreement based upon LFUCG's failure to timely pay for properly invoiced and accepted work. Organization shall provide LFUCG with at least thirty (30) days' advance written notice and an opportunity to cure prior to termination.
- C. Organization acknowledges that LFUCG is a governmental entity, and that the validity of this Agreement is based upon the availability of appropriated funding. In the event that such funding is not appropriated in a future fiscal year, LFUCG's obligations under this Agreement shall automatically expire without penalty to the LFUCG thirty (30) days after written notice to Organization. LFUCG shall exercise any application of this provision in good faith.

7. **REPORTING.** Organization shall provide LFUCG with timely quarterly reports and updates related to the completion of the Projects in the form and manner reasonably specified by LFUCG.

8. **REGISTRATION; COMPLIANCE; AUTHORITY TO SIGN.** Organization shall be lawfully registered or authorized to do business in the Commonwealth of Kentucky and Lexington-Fayette County and shall at all times comply with any and all applicable federal, state, and local laws, ordinances, and regulations. LFUCG may request proof that Organization has timely filed federal, state, or local tax forms which shall be provided by Organization on a timely basis. The person signing this Agreement on behalf of Organization is fully authorized to do so.

9. **INSURANCE; INDEMNITY.** The Risk Management Provisions in Exhibit "A" are incorporated herein as if fully stated.

10. **RECORDS.** Organization shall keep and make available to LFUCG any records related to this Agreement as are necessary to support its performance of the services for a period of at least five (5) years following the expiration or termination of this Agreement, or as otherwise required depending upon the source of funds. Books of accounts shall be kept by Organization and entries shall be made therein of all money, goods, effects, debts, sales, purchases, receipts, payments and any other transactions of Organization related to this Agreement and shall be made available to LFUCG upon request.

- A. LFUCG shall be the owner of all final documents, data, studies, plans, reports, and information prepared by Organization under this Agreement.
- B. Organization understands and agrees that this Agreement and any related documents may be subject to disclosure under the Kentucky Open Records Act and will comply with any reasonable request by LFUCG to provide assistance with such a request.

11. **ACCESS.** Organization shall allow LFUCG any necessary reasonable access to monitor its performance under this Agreement.

12. **CONTRACTUAL RELATIONSHIP ONLY.** In no event shall the parties be construed, held or become in any way for any purpose the employee of the other party, or partners, associates or joint ventures in the conduct of their respective endeavors or otherwise.

13. **EQUAL OPPORTUNITY; FAIRNESS ORDINANCE.** Organization shall provide equal opportunity in employment for all qualified persons, and shall (a) prohibit discrimination in employment because of race, color, creed, national origin, sex, age, sexual orientation, gender identity, or handicap, (b) promote equal employment through a positive, continuing program of equal employment, and (c) cause any subcontractor or agency receiving funds provided pursuant to this Agreement to do so. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices. Organization agrees to comply with LFUCG's Fairness Ordinance (Ordinance No. 201-99) and all sources of applicable law, including those specified in any Exhibit attached to this Agreement and incorporated herein by reference.

14. **SEXUAL HARASSMENT.** Organization must adopt or have adopted a written sexual harassment policy, which shall, at a minimum, contain a statement of current law; a list of prohibited behaviors; a complaint process; and a procedure which provides for a confidential investigation of all complaints. The policy shall be given to all employees and clients and shall be posted at all locations where Organization conducts business. The policy shall be made available to LFUCG upon request.

15. **DISPOSITION OF PROPERTY.** Organization agrees that it shall not sell or otherwise dispose of any goods, property, or equipment acquired and/or improved with any portion of the Funds without first obtaining the consent of LFUCG. Organization agrees that this provision shall survive termination of the Agreement, if this Agreement terminates prior to December 31, 2026. If

Organization breaches this provision, Organization may be liable to LFUCG for that breach in an amount that shall not exceed the fair market value of the goods, property and/or equipment that it sold or otherwise transferred. LFUCG further reserves the right to enforce this provision through any remedy available at law, equity, or in bankruptcy.

16. **INVESTMENT.** Any investment of the Funds received pursuant to this Agreement must fully comply with any restrictions imposed by law.

17. **NO ASSIGNMENT.** Organization may not assign any of its rights and duties under this Agreement without the prior written consent of LFUCG.

18. **NO THIRD PARTY RIGHTS.** This Agreement does not create a contractual relationship with or right of action in favor of a third party against either Organization or LFUCG.

19. **KENTUCKY LAW AND VENUE.** This Agreement shall be governed in all respects by the laws of the Commonwealth of Kentucky and venue for all actions shall lie in the Circuit Court of Fayette County, Kentucky.

20. **AMENDMENTS.** By mutual agreement, the parties to this Agreement may, from time to time, make written changes to any provision hereof. Organization acknowledges that LFUCG may make such changes only upon approval of its legislative authority, the Lexington-Fayette Urban County Council, and the signature of its Mayor.

21. **NOTICE.** Any written notice required by the Agreement shall be delivered by certified mail, return receipt requested, to the following:

22. **WAIVER.** The waiver by either party of any breach of any provision of this Agreement shall not constitute a continuing waiver or waiver of any subsequent breach by either party of either the same or another provision.

23. **ENTIRE AGREEMENT.** This Agreement shall constitute the entire agreement between the parties and no representations, inducements, promises or agreements, oral or otherwise, which are not embodied herein shall be effective for any purpose. This Agreement shall replace any previous agreement between the parties on the same subject matter.

Request for Proposal

The Lexington-Fayette Urban County Government hereby requests proposals for **RFP #24-2022 Nonprofit Capital Grants Program** to be provided in accordance with terms, conditions and specifications established herein.

Online proposals will be received at <https://lexingtonky.ionwave.net/> until **2:00 PM**, prevailing local time, on **June 21, 2022**

Proposals received after the date and time set for opening proposals will not be considered for award of a contract and will be returned unopened to the Proposer. It is the sole responsibility of the Proposer to assure that his/her proposal is received (uploaded to <https://lexingtonky.ionwave.net/>) by the Division of Central Purchasing before the date and time set for opening proposals.

Additional copies of this Request For Proposals are available from the Division of Central Purchasing, Room 338 Government Center, 200 East Main Street, Lexington, KY 40507, (859)-258-3320, at no charge.

Proposals, once submitted, may not be withdrawn for a period of sixty (60) calendar days.

The Proposer must upload one (1) electronic version in PDF format to <https://lexingtonky.ionwave.net/>.

The Lexington-Fayette Urban County Government reserves the right to reject any or all proposals, and to waive technicalities and informalities when such waiver is determined by the Lexington-Fayette Urban County Government to be in its best interest.

Signature of this proposal by the Proposer constitutes acceptance by the Proposer of terms, conditions and requirements set forth herein.

Minor exceptions may not eliminate the proposal. Any exceptions to the specifications established herein shall be listed in detail on a separate sheet and attached hereto. The Lexington-Fayette Urban County Government shall determine whether any exception is minor.

The Lexington-Fayette Urban County Government encourages the participation of minority- and women-owned businesses in Lexington-Fayette Urban County Government contracts. This proposal is subject to Affirmative Action requirements attached hereto.

Please do not contact any LFUCG staff member or any other person involved in the selection process other than the designated contact person(s) regarding the project contemplated under this RFP while this RFP is open and a selection has not been finalized. Any attempt to do so may result in disqualification of the firm's submittal for consideration.

Laws and Regulations

All applicable state laws, ordinances and resolutions (including but not limited to Section 2-33 (Discrimination due to sexual orientation or gender identity) and Chapter 13 (Licenses and Regulations) of the Lexington-Fayette Urban County Government Code of Ordinances, and Resolution No. 484-17 (Minority, Women, and Veteran-Owned Businesses)) and the regulations of all authorities having jurisdiction over the project shall apply to the contract, and shall be deemed to be incorporated herein by reference.

Equal Employment Opportunity

The Entity (regardless of whether construction contractor, non-construction contractor or supplier) agrees to provide equal opportunity in employment for all qualified persons, to prohibit discrimination in employment because of race, color, religion, sex (including pregnancy, sexual orientation or gender identity), national origin, disability, age, genetic information, political affiliation, or veteran status, and to promote equal employment through a positive, continuing program from itself and each of its sub-contracting agents. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.

Kentucky Equal Employment Opportunity Act

The Kentucky Equal Employment Opportunity Act of 1978 (KRS 45.560-45.640) requires that any "county, city, town, school district, water district, hospital district, or other political subdivision of the state shall include in directly or indirectly publicly funded contracts for supplies, materials, services, or equipment hereinafter entered into the following provisions:

"During the performance of this contract, the contractor agrees as follows:

- (1) The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin;
- (2) The contractor will state in all solicitations or advertisements for employees placed by or on behalf of the contractors that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, age, or national origin;
- (3) The contractor will post notices in conspicuous places, available to employees and applicants for employment, setting forth the provision of the nondiscrimination clauses required by this section; and
- (4) The contractor will send a notice to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding advising the labor union or workers' representative of the contractor's commitments under the nondiscrimination clauses."

The Act further provides:

"KRS 45.610. Hiring minorities -- Information required

- (1) For the length of the contract, each contractor shall hire minorities from other sources within the drawing area, should the union with which he has collective bargaining agreements be unwilling to supply sufficient minorities to satisfy the agreed upon goals and timetables.
- (2) Each contractor shall, for the length of the contract, furnish such information as required by KRS 45.560 to KRS 45.640 and by such rules, regulations and orders issued pursuant thereto and will permit access to all books and records pertaining to his employment practices and work sites by the contracting agency and the department for purposes of investigation to ascertain compliance with KRS 45.560 to 45.640 and such rules, regulations and orders issued pursuant thereto.

KRS 45.620. Action against contractor -- Hiring of minority contractor or subcontractor

(1) If any contractor is found by the department to have engaged in an unlawful practice under this chapter during the course of performing under a contract or subcontract covered under KRS 45.560 to 45.640, the department shall so certify to the contracting agency and such certification shall be binding upon the contracting agency unless it is reversed in the course of judicial review.

(2) If the contractor is found to have committed an unlawful practice under KRS 45.560 to 45.640, the contracting agency may cancel or terminate the contract, conditioned upon a program for future compliance approved by the contracting agency and the department. The contracting agency may declare such a contractor ineligible to bid on further contracts with that agency until such time as the contractor complies in full with the requirements of KRS 45.560 to 45.640.

(3) The equal employment provisions of KRS 45.560 to 45.640 may be met in part by a contractor by subcontracting to a minority contractor or subcontractor. For the provisions of KRS 45.560 to 45.640, a minority contractor or subcontractor shall mean a business that is owned and controlled by one or more persons disadvantaged by racial or ethnic circumstances.

KRS 45.630 Termination of existing employee not required, when

Any provision of KRS 45.560 to 45.640 notwithstanding, no contractor shall be required to terminate an existing employee upon proof that employee was employed prior to the date of the contract.

KRS 45.640 Minimum skills

Nothing in KRS 45.560 to 45.640 shall require a contractor to hire anyone who fails to demonstrate the minimum skills required to perform a particular job."

It is recommended that all of the provisions above quoted be included as special conditions in each contract. In the case of a contract exceeding \$250,000, the contractor is required to furnish evidence that his workforce in Kentucky is representative of the available workforce in the area from which he draws employees, or to supply an Affirmative Action plan which will achieve such representation during the life of the contract.

LFUCG Non-Appropriation Clause

Contractor acknowledges that the LFUCG is a governmental entity, and the contract validity is based upon the availability of public funding under the authority of its statutory mandate.

In the event that public funds are unavailable and not appropriated for the performance of the LFUCG's obligations under this contract, then this contract shall automatically expire without penalty to the LFUCG thirty (30) days after written notice to Contractor of the unavailability and non-appropriation of public funds. It is expressly agreed that the LFUCG shall not activate this non-appropriation provision for its convenience or to circumvent the requirements of this contract, but only as an emergency fiscal measure during a substantial fiscal crisis, which affects generally its governmental operations.

In the event of a change in the LFUCG's statutory authority, mandate and mandated functions, by state and federal legislative or regulatory action, which adversely affects the LFUCG's authority to continue its obligations under this contract, then this contract shall automatically terminate without penalty to the LFUCG upon written notice to Contractor of such limitation or change in the LFUCG's legal authority.

Contention Process

Vendors who respond to this invitation have the right to file a notice of contention associated with the RFP process or to file a notice of appeal of the recommendation made by the Director of Central Purchasing resulting from this invitation.

Notice of contention with the RFP process must be filed within 3 business days of the bid/proposal opening by (1) sending a written notice, including sufficient documentation to support contention, to the Director of the Division of Central Purchasing or (2) submitting a written request for a meeting with the Director of Central Purchasing to explain his/her contention with the RFP process. After consulting with the Commissioner of Finance the Chief Administrative Officer and reviewing the documentation and/or hearing the vendor, the Director of Central Purchasing shall promptly respond in writing findings as to the compliance with RFP processes. If, based on this review, a RFP process irregularity is deemed to have occurred the Director of Central Purchasing will consult with the Commissioner of Finance, the Chief Administrative Officer and the Department of Law as to the appropriate remedy.

Notice of appeal of a RFP recommendation must be filed within 3 business days of the RFP recommendation by (1) sending a written notice, including sufficient documentation to support appeal, to the Director, Division of Central Purchasing or (2) submitting a written request for a meeting with the Director of Central Purchasing to explain his appeal. After reviewing the documentation and/or hearing the vendor and consulting with the Commissioner of Finance and the Chief Administrative Officer, the Director of Central Purchasing shall in writing, affirm or withdraw the recommendation.

SELECTION CRITERIA:

See Scope of Work for scoring criteria.

Proposals shall contain the appropriate information necessary to evaluate based on these criteria. A committee composed of government employees as well as representatives of relevant user groups will evaluate the proposals.

AFFIDAVIT


Comes the Affiant, Timothy Johnson, and after being first duly sworn, states under penalty of perjury as follows:

1. His/her name is Timothy Johnson and he/she is the individual submitting the proposal or is the authorized representative of United Way of the Bluegrass, the entity submitting the proposal (hereinafter referred to as "Proposer").
2. Proposer will pay all taxes and fees, which are owed to the Lexington-Fayette Urban County Government at the time the proposal is submitted, prior to award of the contract and will maintain a "current" status in regard to those taxes and fees during the life of the contract.
3. Proposer will obtain a Lexington-Fayette Urban County Government business license, if applicable, prior to award of the contract.
4. Proposer has authorized the Division of Central Purchasing to verify the above-mentioned information with the Division of Revenue and to disclose to the Urban County Council that taxes and/or fees are delinquent or that a business license has not been obtained.
5. Proposer has not knowingly violated any provision of the campaign finance laws of the Commonwealth of Kentucky within the past five (5) years and the award of a contract to the Proposer will not violate any provision of the campaign finance laws of the Commonwealth.
6. Proposer has not knowingly violated any provision of Chapter 25 of the Lexington-Fayette Urban County Government Code of Ordinances, known as "Ethics Act."

7. Proposer acknowledges that "knowingly" for purposes of this Affidavit means, with respect to conduct or to circumstances described by a statute or ordinance defining an offense, that a person is aware or should have been aware that his conduct is of that nature or that the circumstance exists.

EQUAL OPPORTUNITY AGREEMENT

The Law

- Title VII of the Civil Rights Act of 1964 (amended 1972) states that it is unlawful for an employer to discriminate in employment because of race, color, religion, sex, age (40-70 years) or national origin.
- Executive Order No. 11246 on Nondiscrimination under Federal contract prohibits employment discrimination by contractor and sub-contractor doing business with the Federal Government or recipients of Federal funds. This order was later amended by Executive Order No. 11375 to prohibit discrimination on the basis of sex.
- Section 503 of the Rehabilitation Act of 1973 states:

The Contractor will not discriminate against any employee or applicant for employment because of physical or mental disability.

GENERAL PROVISIONS

1. Each Respondent shall comply with all Federal, State & Local regulations concerning this type of service or good.

The Respondent agrees to comply with all statutes, rules, and regulations governing safe and healthful working conditions, including the Occupational Health and Safety Act of 1970, 29 U.S.C. 650 *et. seq.*, as amended, and KRS Chapter 338. The Respondent also agrees to notify the LFUCG in writing immediately upon detection of any unsafe and/or unhealthful working conditions at the job site. The Respondent agrees to indemnify, defend and hold the LFUCG harmless from all penalties, fines or other expenses arising out of the alleged violation of said laws.

2. Failure to submit ALL forms and information required in this RFP may be grounds for disqualification.
3. Addenda: All addenda, if any, shall be considered in making the proposal, and such addenda shall be made a part of this RFP. Before submitting a proposal, it is incumbent upon each proposer to be informed as to whether any addenda have been issued, and the failure to cover in the bid any such addenda may result in disqualification of that proposal.

Only letters, or other formal written requests for modifications or corrections of a previously submitted proposal which is addressed in the same manner as the proposal, and received by LFUCG prior to the scheduled closing time for receipt of proposals, will be accepted. The proposal, when opened, will then be corrected in accordance with such written request(s), provided that the written request is contained in a sealed envelope which is plainly marked "modifications of proposal".
7. Clarification of Submittal: LFUCG reserves the right to obtain clarification of any point in a bid or to obtain additional information from a Respondent.
8. Bribery Clause: By his/her signature on the bid, Respondent certifies that no employee of his/hers, any affiliate or Subcontractor, has bribed or attempted

to bribe an officer or employee of the LFUCG.

9. **Additional Information:** While not necessary, the Respondent may include any product brochures, software documentation, sample reports, or other documentation that may assist LFUCG in better understanding and evaluating the Respondent's response. Additional documentation shall not serve as a substitute for other documentation which is required by this RFP to be submitted with the proposal,
10. **Ambiguity, Conflict or other Errors in RFP:** If a Respondent discovers any ambiguity, conflict, discrepancy, omission or other error in the RFP, it shall immediately notify LFUCG of such error in writing and request modification or clarification of the document if allowable by the LFUCG.
11. **Agreement to Bid Terms:** In submitting this proposal, the Respondent agrees that it has carefully examined the specifications and all provisions relating to the work to be done attached hereto and made part of this proposal. By acceptance of a Contract under this RFP, proposer states that it understands the meaning, intent and requirements of the RFP and agrees to the same. The successful Respondent shall warrant that it is familiar with and understands all provisions herein and shall warrant that it can comply with them. No additional compensation to Respondent shall be authorized for services or expenses reasonably covered under these provisions that the proposer omits from its Proposal.
12. **Cancellation:** If the services to be performed hereunder by the Respondent are not performed in an acceptable manner to the LFUCG, the LFUCG may cancel this contract for cause by providing written notice to the proposer, giving at least thirty (30) days notice of the proposed cancellation and the reasons for same. During that time period, the proposer may seek to bring the performance of services hereunder to a level that is acceptable to the LFUCG, and the LFUCG may rescind the cancellation if such action is in its best interest.

A. Termination for Cause

- (1) LFUCG may terminate a contract because of the contractor's failure to perform its contractual duties
- (2) If a contractor is determined to be in default, LFUCG shall notify the contractor of the determination in writing, and may include a specified date by which the contractor shall cure the identified deficiencies. LFUCG may proceed with termination if the contractor fails to cure the deficiencies within the specified time.

- (3) A default in performance by a contractor for which a contract may be terminated shall include, but shall not necessarily be limited to:

B. At Will Termination


Notwithstanding the above provisions, the LFUCG may terminate this contract at will in accordance with the law upon providing thirty (30) days written notice of that intent, Payment for services or goods received prior to termination shall be made by the LFUCG provided these goods or services were provided in a manner acceptable to the LFUCG. Payment for those goods and services shall not be unreasonably withheld.

13. **Assignment of Contract:** The contractor shall not assign or subcontract any portion of the Contract without the express written consent of LFUCG. Any purported assignment or subcontract in violation hereof shall be void. It is expressly acknowledged that LFUCG shall never be required or obligated to consent to any request for assignment or subcontract; and further that such refusal to consent can be for any or no reason, fully within the sole discretion of LFUCG.
14. **No Waiver:** No failure or delay by LFUCG in exercising any right, remedy, power or privilege hereunder, nor any single or partial exercise thereof, nor the exercise of any other right, remedy, power or privilege shall operate as a waiver hereof or thereof. No failure or delay by LFUCG in exercising any right, remedy, power or privilege under or in respect of this Contract shall affect the rights, remedies, powers or privileges of LFUCG hereunder or shall operate as a waiver thereof.
15. **Authority to do Business:** The Respondent must be a duly organized and

authorized to do business under the laws of Kentucky. Respondent must be in good standing and have full legal capacity to provide the services specified under this Contract. The Respondent must have all necessary right and lawful authority to enter into this Contract for the full term hereof and that proper corporate or other action has been duly taken authorizing the Respondent to enter into this Contract. The Respondent will provide LFUCG with a copy of a corporate resolution authorizing this action and a letter from an attorney confirming that the proposer is authorized to do business in the State of Kentucky if requested. All proposals must be signed by a duly authorized officer, agent or employee of the Respondent.

16. **Governing Law:** This Contract shall be governed by and construed in accordance with the laws of the Commonwealth of Kentucky. In the event of any proceedings regarding this Contract, the Parties agree that the venue shall be the Fayette County Circuit Court or the U.S. District Court for the Eastern District of Kentucky, Lexington Division. All parties expressly consent to personal jurisdiction and venue in such Court for the limited and sole purpose of proceedings relating to this Contract or any rights or obligations arising thereunder. Service of process may be accomplished by following the procedures prescribed by law.
17. **Ability to Meet Obligations:** Respondent affirmatively states that there are no actions, suits or proceedings of any kind pending against Respondent or, to the knowledge of the Respondent, threatened against the Respondent before or by any court, governmental body or agency or other tribunal or authority which would, if adversely determined, have a materially adverse effect on the authority or ability of Respondent to perform its obligations under this Contract, or which question the legality, validity or enforceability hereof or thereof.
18. Contractor understands and agrees that its employees, agents, or subcontractors are not employees of LFUCG for any purpose whatsoever. Contractor is an independent contractor at all times during the performance of the services specified.
19. Contractor [or Vendor or Vendor's Employees] will not appropriate or make use of the Lexington-Fayette Urban County Government (LFUCG) name or any of its trade or service marks or property (including but not limited to any logo or seal), in any promotion, endorsement, advertisement, testimonial or similar use without the prior written consent of the government. If such consent is granted LFUCG reserves the unilateral right, in its sole discretion, to immediately terminate and revoke such use for any reason whatsoever. Contractor agrees that it shall cease and desist from any unauthorized use immediately upon being notified by LFUCG.

20. If any term or provision of this Contract shall be found to be illegal or unenforceable, the remainder of the contract shall remain in full force and such term or provision shall be deemed stricken.

**AMENDMENT 1 —

The bidder agrees and understands that in addition to all conditions stated within the attached bid documents, the following conditions will also apply to any Agreement entered between bidder and LFUCG, if LFUCG classifies the subject matter of this bid as an expenditure under the American Rescue Plan Act. The bidder further certifies that it can and will comply with these conditions, if this bid is accepted and an Agreement is executed:

1. Any Agreement executed as a result of acceptance of this bid may be governed in accordance with 2 CFR Part 200 and all other applicable Federal law and regulations and guidance issued by the U.S. Department of the Treasury.
2. Pursuant to 24 CFR 85.43, any Agreement executed as a result of acceptance of this bid can be terminated if the contractor fails to comply with any term of the award. This Agreement may be terminated for convenience in accordance with 24 CFR 85.44 upon written notice by LFUCG. Either party may terminate this Agreement with thirty (30) days written notice to the other party, in which case the Agreement shall terminate on the thirtieth day. In the event of termination, the contractor shall be entitled to that portion of total compensation due under this Agreement as the services rendered bears to the services required. Either party may terminate this Agreement for good cause shown with forty-five (45) days written notice, which shall explain the party’s cause for the termination. If the parties do not reach a settlement before the end of the 45 days, then the Agreement shall terminate on the forty-fifth day.
3. The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, sexual orientation, gender identity, or national origin. The contractor will take affirmative action to ensure that applicants are employed and that employees are treated during employment without regard to their race, color, religion, sex, sexual orientation, gender identity, or national origin. Such action shall include, but not be limited to the following:
 - (1) Employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided setting forth the provisions of this nondiscrimination clause.

- (7) In the event of the contractor's noncompliance with the nondiscrimination clauses of this contract or with any of the said rules, regulations, or orders, this contract may be canceled, terminated, or suspended in whole or in part, and the contractor may be declared ineligible for further government contracts or federally assisted construction contracts in accordance with procedures authorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.
- (8) The contractor will include the portion of the sentence immediately preceding paragraph (1) and the provisions of paragraphs (1) through (8) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. The contractor will take such action with respect to any subcontract or purchase order as the administering agency may direct as a means of enforcing such provisions, including sanctions for noncompliance.

7. The contractor shall include these requirements in numerical paragraphs 5 and 6 in each subcontract exceeding \$100,000 financed in whole or in part with American Rescue Plan Act funding.

8. The contractor shall comply with all applicable standards, orders, or regulations issued pursuant to the Federal Water Pollution Control Act, as amended, 33 U.S.C. 1251 et seq.



INDEMNIFICATION AND HOLD HARMLESS PROVISION

- (1) It is understood and agreed by the parties that Consultant hereby assumes the entire responsibility and liability for any and all damages to persons or property caused by or resulting from or arising out of any act or omission on the part of Consultant or its employees, agents, servants, owners, principals, licensees, assigns or subcontractors of any tier (hereinafter "Consultant") under or in connection with this agreement and/or the provision of goods or services and the performance or failure to perform any work required thereby.
- (2) Consultant shall indemnify, save, hold harmless and defend the Lexington-Fayette Urban County Government and its elected and appointed officials, employees, agents, volunteers, and successors in interest (hereinafter "LFUCG") from and against all liability, damages, and losses, including but not limited to, demands, claims, obligations, causes of action, judgments, penalties, fines, liens, costs, expenses, interest, defense costs and reasonable attorney's fees that are in any way incidental to or connected with, or that arise or are alleged to have arisen, directly or indirectly, from or by Consultant's performance or breach of the agreement and/or the provision of goods or services provided that: (a) it is attributable to personal injury, bodily injury, sickness, or death, or to injury to or destruction of property (including the loss of use resulting therefrom), or to or from the negligent acts, errors or omissions or willful misconduct of the Consultant; and (b) not caused solely by the active negligence or willful misconduct of LFUCG.
- (3) Notwithstanding, the foregoing, with respect to any professional services performed by Consultant hereunder (and to the fullest extent permitted by law), Consultant shall indemnify, save, hold harmless and defend LFUCG from and against any and all liability, damages and losses, including but not limited to, demands, claims, obligations, causes of action, judgments, penalties, fines, liens, costs, expenses, interest, defense costs and reasonable attorney's fees, for any damage due to death or injury to any person or injury to any property (including the loss of use resulting therefrom) to the extent arising out of, pertaining to or relating to the negligence, recklessness or willful misconduct of Consultant in the performance of this agreement.
- (4) In the event LFUCG is alleged to be liable based upon the above, Consultant shall defend such allegations and shall bear all costs, fees and expenses of such defense, including but not limited to, all reasonable attorneys' fees and expenses, court costs, and expert witness fees and expenses, using attorneys approved in writing by LFUCG, which approval shall not be unreasonably withheld.

- (5) These provisions shall in no way be limited by any financial responsibility or insurance requirements, and shall survive the termination of this agreement.
- (6) LFUCG is a political subdivision of the Commonwealth of Kentucky. CONSULTANT acknowledges and agrees that LFUCG is unable to provide indemnity or otherwise save, hold harmless, or defend the CONSULTANT in any manner.

Section 1: Directly Provide or Indirectly Facilitate the Provision of Services to Low income, Underserved, or Marginalized Lexington-Fayette County Residents: Please provide a brief description of your agency's mission and objectives.

United Way of the Bluegrass (UWBG) has been a leader and motivator of change for real solutions in Central Kentucky for over 100 years. Each day, we fight for the health and basic needs, education, and financial stability of every person in the ten counties we represent, including Fayette County. To live better, we must LIVE UNITED.

UWBG has developed systems to evaluate the quality and success of the programs and collaborations that our donors invest in, assuring that they will have maximum impact.

UWBG spearheads several key initiatives to serve the community. Our WayPoint strategy was born out of an in-depth analysis of our regional community and current demographics, and a meaningful understanding of what our community needs to evolve into a better, more resilient Bluegrass. WayPoint's mission is to create an access point for families and individuals (essentially a one-stop shop), and to provide vital programming to people living in underserved neighborhoods and communities of color. Each WayPoint Center brings together the region's most effective nonprofit, government, and corporate stakeholders to leverage their strengths to solve our community's biggest challenges. WayPoint Centers offer a coordinated ecosystem of partners and programs to have the greatest impact on local families, rooted in a physical and place-based anchor located in their communities. The Council of the Lexington-Fayette Urban County Government (LFUCG) passed Resolution # 605-2021 which authorized the City to enter into a redevelopment agreement with United Way of

the Bluegrass for the renovation and adaptive use of the Palmer Pharmacy building. In furtherance of those efforts, UWBG is seeking a combined Operational and Facilities grant of \$742,140 to use towards the renovation and repurposing of the former Palmer Pharmacy Building as a neighborhood-based hub for health and human services programming (WayPoint Center) to benefit families across Lexington, particularly those living in the surrounding East End neighborhood. The total cost of the project is approximately \$1.2 million.

Section 2: Demonstrated Need

United Way of the Bluegrass (UWBG) "WayPoint Centers are the next step in the evolution of delivery of non-profit-based health and human services in Lexington. UWBG's WayPoint strategy was born out of an in-depth analysis of our regional community and demographics, and a meaningful understanding of what our community needs to evolve into a better, more resilient Bluegrass. WayPoint's mission is to create a One-Stop access point for families and individuals, and to provide vital programming to people living in underserved neighborhoods and communities of color. WayPoint Centers coordinate an ecosystem of partners and programs to have the greatest impact on local families, centered in a place-based anchor in their communities.

UWBG launched its inaugural three (3) WayPoint Centers in neighborhoods across our region where the data suggested that our help is needed most. The three centers are located in 1) Lexington's West End (Black and Williams Recreational Center), 2) Lexington's East End (temporarily in the Charles Young Recreational Center) and 3) in

Paris, KY at the Bourbon-Paris YMCA. Our team of community impact professionals meet participants where they are on their journey forward and provide personalized support to help stabilize individuals in crisis, move families toward self-sufficiency, support student success and achievement and create innovative solutions to break the cycle of generational poverty.

WayPoint Centers are a place where the community can go to lean on a trusted neighbor and access exceptional services. WayPoint Centers will help stabilize, grow, and empower every person and family, no matter their current financial situation or zip code. UWBG believes that one's zipcode should not determine one's success in life or life expectancy.

UWBG now seeks to acquire and rehabilitate the Palmer Pharmacy Building in Fayette County for use as a WayPoint Center. Dr. Zirl Palmer was a veteran of the Second World War and married fellow veteran Marian Elspy Sidney. The couple moved to Lexington, Kentucky in 1952 where Dr. Palmer purchased the property on the southeast corner of 5th Street and Chestnut Street, and established "Palmer's Pharmacy, Luncheonette, and Doctor's Office" in 1961. Dr. Palmer's drugstore was the only black-owned drugstore in town, and Palmer's business fostered relationships in the community and was a boon to the neighborhood.

Following in the footsteps and the spirit of Dr. Palmer, UWBG's WayPoint Centers serves as that same nexus between people and services, helping to provide essential resources and foster collaborations between community stakeholders. By securing the resources to rehabilitate and renovate the Palmer Pharmacy Building, UWBG will memorialize the story and accomplishments of Dr. Zirl Palmer and safeguard it in a

place where community members and Lexingtonians can both learn about and celebrate this accomplished son of Lexington.

The ability to relocate and expand services from the existing East End WayPoint, temporarily housed in the Charles Young Center, into the Palmer Pharmacy building will ensure that one of our city's most underserved neighborhoods has a one-stop location offering a multiplicity of services in a place-based model where families are able to access the resources they need to thrive, not just survive.

While Lexington's community of non-profit organizations offers a wealth of programming to our underserved and low-income neighbors, in almost every case, individuals who reside in our community's most vulnerable neighborhoods must travel to access those essential services. The WayPoint Center at the Palmer Pharmacy Building will bring critical and empowering services from across the city to the East-End neighborhood at a centralized location that is walkable for neighborhood residents.

Staff at the East End WayPoint Center are already helping families to assess and address their specific needs in as holistic a way possible, focusing on family financial stability, and building in a bundled-services approach to address a host of other possible needs. This suite of on-site services provides families with more opportunities to achieve stability, which then allows families to explore ways in which they can grow and empower themselves to achieve new heights. Neighborhoods grow stronger and more resilient when families are empowered with the resources they need to thrive. WayPoint Centers are becoming a cornerstone of the neighborhoods they serve, with community-based events that bring families together and call attention to WayPoint services.

Because of the central location of the Palmer Building, UWBG believes that a WayPoint Center located here would create an access point for the entire East-End Neighborhood (in this case, Fayette County Census Tracts 3 and 4). The data associated with this neighborhood demonstrates drastic inequality and the need for access to services:

- Per-capita Income: \$12,911
- Household Income: \$21,486
- Children Below Poverty: 62%
- Non-White: 63%
- Homes Rented: 74%

In addition, because this neighborhood, as defined by the census tract boundaries, overlaps well within the Fayette County Public Schools districting map for William Wells Brown Elementary School, it is possible to approximate the impact of families' lack of access on their children's ability to succeed. For example:

- The percentage of neighborhood students reading on grade level by 3rd grade: 17.3%
- The percentage of neighborhood students who are on grade level in math by 3rd grade: 21.2%.
- The percentage of neighborhood students who receive free/reduced price lunch: 97%

UWBG intends to restore and rehabilitate the Palmer Pharmacy Building in a way that pays homage to Dr. Zirl Palmer and his legacy of service to the Lexington Community. UWBG will work with the local historical preservation society to ensure that the exterior of the facility remains reflective of Dr. Palmer's accomplishments and vision, while the

interior may feature an exhibit honoring his works. Dr. Palmer's name will also be prominently featured as a part of the program's nomenclature (for example, the Dr. Zirl Palmer WayPoint Center). The City of Lexington has named UWBG as LFUCG's Rehabilitation Partner in a resolution dated November 4, 2021 (#605-2021). A copy of that resolution is provided as an attachment to our application.

The center will serve as an anchor point within the community for a robust partnership of health and social service nonprofits to come together and offer their services to the surrounding community as well as a community resource for other residents and organizations to enjoy. UWBG will deliver family financial stability programming at the new proposed facility, which will include a suite of programs designed to empower families by providing the resources necessary to achieve financial growth. Research shows that families who are financially stable are more than twice as likely to have kids that are successful in school. When families succeed, children succeed. Further, when children are successful in school, neighborhoods begin to change, grow, and become healthier.

Programming at the center includes:

- **Stabilization:** Individualized 1-on-1 budget counseling; Free year-round income tax services; Money management workshops; Community financial empowerment and awareness events
- **Growth:** Individualized 1-on-1 debt and credit counseling; Savings habit building; Access to mainstream banking products
- **Empowerment:** Asset acquisition; Home purchase; Small business startup

WayPoint Center financial stability programming is coupled with on-site bundled services designed to meet immediate needs and promote long-term stability and reinforced by an ecosystem of partners coordinating to best serve neighborhood families. National research from the Annie E. Casey Foundation shows that families who receive “bundled services” (more than one financial stability service, and/or financial stability services combined with wrap-around services to meet other immediate needs), are more than three times more likely to achieve their economic goals (<https://www.aecf.org/blog/bundling-services-to-boost-the-financial-security-of-low-income-families>). Furthermore, neighborhood stability is increasing one family at a time through WayPoint’s unique set of interventions, in turn stabilizing the neighborhood’s tax base and encouraging businesses to invest in the neighborhood. Examples of the bundled services at the center will include the following:

- UWBG’s year round tax preparation services known as Central Kentucky Economic Empowerment Program (CKEEP)
- Programs that help families to maximize their economic well-being and career potential through job training, job placement, skill development and financial counseling (Jubilee Jobs of Lexington; Apprisen; Community Action Council; UWBG; Urban League, local banks and other financial institutions)
- Programs creating access to basic needs such as food, clothing, and rent and utility assistance (Community Action Council)
- Programs creating access to healthcare and promoting healthy lifestyles (University of Kentucky, American Heart Association)

- Programs that help families to prepare young children for kindergarten (Child Care Council; YMCA of Central Kentucky)
- Programs that help students succeed in school, such as Nontraditional Instruction Program (NTI) supports, tutoring, and homework help (YMCA of Central Kentucky; Urban League; Big Brothers Big Sisters)
- Programs that help families to feel safe and secure in their neighborhood (Urban League; The Nest, One Lexington)

Section 3: Applicant Capacity for Project and Meeting ARPA Requirements

UWBG is leveraging its 101-year history as a collaborator and consensus builder within our community to build the most effective and robust ecosystem of partners possible to address the needs of the East End neighborhood. In addition, the Palmer Pharmacy WayPoint site will be staffed full-time by facility staff who are intimately familiar with and connected to the community.

UWBG has been a part of the Lexington philanthropic community for more than 100 years. In that time, it has built a long track record of building collaboration among our community's diverse non-profit organizations. In fact, last year alone, UWBG partnered with over 60 non-profit agencies across the region to provide over 120,000 instances of service to low-income and underserved Central Kentuckians in the areas of education, income, and health. UWBG sees the WayPoint Initiative as the next step in the evolution in the way that we impact our community, building on its past success by bringing partners together around a common cause.

UWBG will continue to leverage our role as a convener of non-profit organizations to make a difference in the lives of Lexingtonians, but the WayPoint Center at the Palmer Pharmacy Building will allow us to do it in a way that brings critical services to the folks in our City's most underserved neighborhoods at a larger scale. With WayPoint as an anchor point within the community, UWBG partner agencies can and will provide their services right next door to some of our most vulnerable friends and neighbors. Within walking distance of their homes, families now have access to basic needs services, financial stability services, out-of-school educational supports, kindergarten readiness

initiatives, workforce development programming, mentoring and tutoring services, neighborhood safety initiatives, and much more.

UWBG believes that it is uniquely positioned to bring a collaborative, non-profit-based, holistic program to the Palmer Pharmacy Building in a way that both addresses the specific needs of the surrounding neighborhood and pays homage to Dr. Palmer's incredible legacy.

UWBG has a wealth of experience in managing federal, state, and local government grants. UWBG currently is or has operated grant funded programs through the US Internal Revenue Service, Corporation for National and Community Service, the Kentucky Cabinet for Health and Family Services, and many others. UWBG and its executive management team's history in managing grant funded programs of this kind dates back over 20 years. In addition, UWBG will leverage its long-time partnerships with firms involved in construction, project management, and capital projects in order to ensure that the rehabilitation of the Palmer Pharmacy Building is completed with precision and expediency. Finally, UWBG is well versed in seeking input from low and moderate income and underserved communities and will leverage this experience to ensure that the community surrounding the Palmer Building will be as involved in the process of its rehabilitation as possible.

UWBG will comply with all American Rescue Plan Act (ARPA) requirements should it be awarded this grant, including record keeping, workplace standards, anti-discrimination policies, and all requirements outlined in the Certification of Compliance for APRA funds.

Section 4: Operational Feasibility

The WayPoint Initiative officially launched in July of 2021. UWBG is currently using space at the city-owned Charles Young Center on a temporary basis until it can finalize plans for a permanent, more appropriate sized home for WayPoint in the East End. From a programmatic perspective, nearly two years of work has already been completed, including preparatory work in establishing the foundation and framework for WayPoint. From a construction perspective, UWBG recognizes that it may still take a little time before the initiative's permanent home is complete. If we are successful in raising the necessary funds needed to complete restoration of the building, UWBG would begin immediately:

- Seek contracting proposals: 2022
- Filing/Permitting Deadlines: Q4 2022
- Construction/Renovation Begins: Q1 2023
- Construction/Renovation Ends: December 2023
- WayPoint Center at the Palmer Pharmacy Building Opens to the Public: January 2024

The WayPoint Initiative forms the cornerstone of UWBG's community impact work. Fundraising for both the programming native to the Center, and for funding for partner programs within the facility, therefore, will be integrated with UWBG's normal fundraising operation. We approximate a need for \$250,000 per year in operating revenue for the WayPoint Center at the Palmer Pharmacy Building, which will be incorporated with UWBG's annual multi-million-dollar fundraising campaign.

UWBG is currently in the process of seeking partners who will assist with the remainder of the cost of rehabilitating the Palmer Pharmacy Building. Financing is expected to be drawn from a combination of private investments, sponsorship and grants, and in-kind donations of construction, repair, and general contracting from corporate partners in the community. One such partner is the Blue Grass Trust (BGT), with which we jointly applied for funding earlier this year and secured a \$50,000 grant, as well as another \$50,000 in private contributions to support redevelopment of the pharmacy building should UWBG become the rehabilitation partner.

In a broad sense, over the course of the next five years, the Palmer Building-based Waypoint Center will help to improve the overall health of its surrounding neighborhood. The health of a community can be measured in many ways, but United Way and its partners have agreed that Waypoint Centers can assess the health of their neighborhoods based on how well its kids and families are doing. We believe that improvement in school performance, in household income, in homeownership, and many more community demographics are solid indicators of improvements in neighborhood health, in family wellness, and in meeting the needs of our most underserved neighbors. Anecdotally, in other United Way jurisdictions, similar types of collective impact initiatives (like WayPoint) have shown to contribute to the reduction in neighborhood violence as employment and other economic opportunities have become more readily available. Therefore, data that Center staff will track will relate not just to the individuals who they connect to needed services every day, but also to the overall well-being of the East End neighborhood.

Together with its partners, UWBG will build more resiliency within Lexington communities (particularly those of color), promote equity and opportunity, and inspire civic engagement within neighborhoods- one family at a time. And the success of the partnership will be judged by the health of the neighborhood itself, starting with the kids, and reaching all the way to its seniors.

By directly addressing the problem of access for underserved and low-income residents in the surrounding neighborhood, the WayPoint Center is currently, and will continue to create lasting, positive change for an entire community by addressing the holistic, complex, and interwoven needs of families, thus creating a brighter tomorrow for the entire neighborhood.

Section 5: Cost Analysis

~~UWBG has developed Facilities and Operational Budget requests for the project. Our total Facilities Budget Request is \$494,034 and covers costs associated with building improvement and includes selective demolition, carpentry, masonry, HVAC and other systems upgrades. A detailed line item budget is provided as an attachment.~~

Our Operational Budget Request is \$248,106. This budget includes costs essential to the operation of services within the facility such as a wheelchair lift, visual displays and signage, lighting, and IT infrastructure and equipment. Included costs are in line with LFUCG's most recent building renovation estimate, a detailed version of which is attached to this application. UWBG has utilized this estimate in order to project reasonable costs that are in line with market rates. The total cost of the project is \$1,163,000. The remaining funding is being raised from other public and private funding sources, described in Section 4.
