Re: Requested Zoning Ordinance Text Amendment

Dear Neighborhood Association Representative:

This letter is to inform you of a recent request for a change to the Zoning Ordinance, also known as a "text amendment." This request was initiated by the Lexington-Fayette Urban County Planning Commission. The Planning Commission will review this proposal at a public hearing scheduled for the afternoon of <u>Thursday</u>, <u>August 25<sup>th</sup>, 2022</u>. The proposed regulations related to the text amendment are available on the Division of Planning website at:

The purpose of this text amendment is to update the "intent" statement for numerous zoning categories to more clearly align with the adopted Comprehensive Plan. Intent statements are included for each zoning category and are meant to explain the location, criteria and/or purpose of the zone. This text amendment includes proposed changes to Articles 8, 10, 11, 22, and 23 of the LFUCG Zoning Ordinance.

Copies of the staff report on this matter will be available three weeks prior to the Commission's public hearing, which is scheduled to begin at **<u>1:30 p.m.</u>** on <u>Thursday, August 25<sup>th</sup>, 2022</u>. The hearing will be held in the 2nd Floor Council Chambers, LFUCG Government Center Building, at 200 East Main Street, Lexington.
