TEMPORARY CONSTRUCTION EASEMENT

This TEMPORARY CONSTRUCTION EASEMENT is made and entered into this the 3/57 day of August, 2023, by and between KENNETH R. BOLL and KAREN E. BOLL, husband and wife, 4011 Todds Road, Lexington, Kentucky 40509, which is the in-care of tax mailing address for the current year ("Grantors"), and LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, 200 East Main Street, Lexington, Kentucky 40507, ("Grantee").

WITNESSETH:

That for and in consideration of the sum of FIVE HUNDRED DOLLARS AND 00/100 (\$500.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Grantors have BARGAINED and SOLD and do hereby GIVE, GRANT and CONVEY unto the Grantee, its successors and assigns, temporary right to excavate, grade, construct, alter, re-grade and perform

Return to: Cynthia Cannon-Ferguson LFUCG, Dept. of Law, 11th Floor 200 East Main Street Lexington, KY 40507 related work for the purpose of stormwater improvements and construction, installation and relocation through and across the following tract of land located in the confines of Lexington, Fayette County, Kentucky, depicted on the attached Exhibit "A", and more particularly described as follows, to wit:

Temporary Construction Easement Barnard Drive Stormwater Improvement Project (a portion of 4011 Todds Road)

All of that tract or parcel of land located north of Todds Road (formerly known as Walnut Hill-Chilesburg Road) at the west side of the Boll Property in Lexington, Fayette County, Kentucky, and more fully described and bounded as follows, to-wit:

STARTING at the intersection of the Kentucky Transportation Cabinet right-of-way and the property corner of Boll (Deed Book 1669, Page 469); thence along the property line S 43°22'00" W, 8.87 feet to the real *POINT OF BEGINNING* for the temporary construction easement (P.O.B.); thence S 44°08'17" E, 25.62 feet; thence S 45°44'32" W, 40.00 feet; thence N 44°19'19" W, 14.95 feet; thence again along said property boundary N 12°36'00" E, 11.36 feet; thence again along said property boundary N 32°17'00" E, 17.00 feet; thence again along said property boundary N 43°42'00" E, 14.03 feet to the **TRUE POINT OF BEGINNING**; and,

The above described parcel contains 910 sq. ft. of temporary construction easement; and

Being a portion of the property conveyed to Kenneth R. Boll and Karen E. Boll, husband and wife, by Deed dated April 5, 1993, of record in Deed Book 1669, Page 469, in the Fayette County Clerk's Office.

TO HAVE AND TO HOLD said easement together with all rights, appurtenances, and improvements thereunto belonging unto said Grantee, its successors and assigns, for the purposes and uses herein designated.

The above-described temporary construction easement runs with the land for the duration of the improvement project and is binding upon the successors and assigns of the Grantors. The temporary construction easement shall take effect upon the commencement of construction of the project and will expire upon the completion of the project.

Grantors do hereby release and relinquish unto the Grantee, its successors and assigns forever, all of their right, title, and interest in and to the property to the extent of the interest conveyed herein, including all exemptions allowed by law, and does hereby covenant to and with the Grantee, its successors and assigns forever, that they are lawfully seized in fee simple of said property and have good right to sell and convey the same as herein done, and that they will **WARRANT GENERALLY** said title.

The obtaining of this easement was authorized by Resolution 157-2023, passed by the Lexington-Fayette Urban County Council on March 23, 2023. Pursuant to KRS 382.135(2)(a), this temporary construction easement, which pertains to a public utility, need not contain a statement of consideration.
