14. **No Waiver:** No failure or delay by LFUCG in exercising any right, remedy, power or privilege hereunder, nor any single or partial exercise thereof, nor the exercise of any other right, remedy, power or privilege shall operate as a waiver hereof or thereof. In the event of any proceedings regarding this matter, the bidder agrees that the venue shall be the Fayette County Circuit Court or the U.S. District Court for the Eastern District of Kentucky, Lexington Division and that the bidder expressly consents to personal jurisdiction and venue in such Court for the limited and sole purpose of proceedings relating to these matters or any rights or obligations arising thereunder.
17. **Ability to Meet Obligations:** Bidder affirmatively states that there are no actions, suits or proceedings of any kind pending against bidder or, to the knowledge of the bidder, threatened against the bidder before or by any court, governmental body or agency or other tribunal or authority which would, if adversely determined, have a materially adverse effect on the authority or ability of bidder to perform its obligations under this bid response or bid contract, or which question the legality, validity or enforceability hereof or thereof.

Each graphic kit is to consist of Front Bumper/Corners (DS & PS), Front Fender (DS & PS), Front Door (DS & PS), Rear Door (DS & PS), Rear Fender (DS & PS), Rear Bumper Corners (DS & PS), (2) Division of Police shields, "Lexington" Lettering (DS & PS), (3) sets of Unit Numbers, and (1) set of Roof Numbers. The kit is to be thermal sealed in a polybag and packaged in such a way to ensure no folding, wrinkling and/or Premask/Liner pop off the graphic. Due to the size, roof number panels for each kit are to be packaged separately

PART LABELING: Each Graphic Panel is to be labeled as to vehicle side and position as applicable (i.e. Driver Side Front Fender)
