AN ORDINANCE AMENDING THE AUTHORIZED STRENGTH BY ABOLISHING TEN (10) CLASSIFIED POSITIONS OF EARLY CHILD CARE TEACHER, GRADE 512E, AND CREATING TEN (10) CLASSIFIED POSITIONS OF EARLY CHILD CARE TEACHER, GRADE 512N, IN THE DIVISION OF FAMILY SERVICES, THEREBY CHANGING THE FAIR LABOR STANDARDS ACT (FLSA) STATUS OF THE POSITIONS FROM EXEMPT TO NON-EXEMPT; TRANSFERRING ALL INCUMBENTS TO THE NON-EXEMPT POSITION; AND CONVERTING THE BIWEEKLY SALARY OF ALL INCUMBENTS TO AN HOURLY RATE OF PAY, EFFECTIVE JULY 1, 2024.
