

RESOLUTION NO. 437 - 2013

A RESOLUTION CHANGING THE PROPERTY ADDRESS NUMBERS OF 207-209 EAST SEVENTH STREET TO 207 EAST SEVENTH STREET, OF 1391 WEST MAIN STREET TO 1389 WEST MAIN STREET, AND OF 6784 OLD RICHMOND ROAD TO 6398 OLD RICHMOND ROAD; AND CHANGING THE STREET NAME AND PROPERTY ADDRESS NUMBER OF 2200 INGLEWOOD CIRCLE TO 3929 PEPPERTREE DRIVE, ALL EFFECTIVE THIRTY DAYS FROM PASSAGE.

WHEREAS, the Lexington-Fayette Urban County Government has created a Geographic Information System ("GIS"); and

WHEREAS, the GIS street mapping and addressing project is the foundation for the Urban County Government's enhanced 911 Emergency Telephone Communication System (the "911 System"); and

WHEREAS, in order for the GIS and 911 Systems to function properly it is imperative that street names and property addresses conform to the standards established in Section 17-2 through 17-4 of the Code of Ordinances; and

WHEREAS, various street names and property addresses located in several Council Districts do not meet the Code requirements and changes should be made to conform to the Code and to accomplish the goals of the GIS and 911 System projects.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That the property address numbers of the following properties be and hereby are changed as follows:

(a) East Seventh Street:

<u>Current</u>	<u>New</u>
207-209 East Seventh Street	207 East Seventh Street

(b) West Main Street:

<u>Current</u>	<u>New</u>
1391 West Main Street	1389 West Main Street

(c) Old Richmond Road:

<u>Current</u>	<u>New</u>
6784 Old Richmond Road	6398 Old Richmond Road

Section 2 – That the street name and property address number of the following property be and hereby is changed as follows:


(a) Inglewood Circle: That the name of Inglewood Circle located at 2200 Inglewood Circle is changed to Peppertree Drive and the following number change is made:

3929 Peppertree Drive

Section 3 – That this Resolution shall be effective thirty (30) days from passage.
