ORDINANCE NO. _____ - 2023

AN ORDINANCE AMENDING ARTICLE 8-16 OF THE ZONING ORDINANCE TO RECATEGORIZE COMMUNITY CENTER, DAY SHELTER, AND ADULT DAY CARE USES FROM A PRINCIPAL USE TO A CONDITIONAL USE WITHIN THE NEIGHBORHOOD BUSINESS (B-1) ZONE (KEITH CLARK).

WHEREAS, at a Public Hearing held on November 17, 2022, a petition for an amendment to Article 8-16 of the Lexington Fayette Urban County Government Zoning Ordinance to re-categorize community center, day shelter and adult day care uses from a principal use to a conditional use within the Neighborhood Business (B-1) zone was presented to the Urban County Planning Commission; said Commission recommending disapproval of the requested amendment by a vote of 10-0; and

WHEREAS, this Council disagrees with the recommendation of the Planning Commission; and

WHEREAS, the recommendation form of the Planning Commission is attached hereto and incorporated herein by reference.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That Articles 8-16(b)(37) and 8-16(b)(42) be and hereby are deleted, renumbering sections, and Article 8-16(b) of the Zoning Ordinance of the Lexington-Fayette Urban County Government, related to principal uses in the Neighborhood Business (B-1) Zone, be and hereby is amended in pertinent part to read as follows:

Sec. 8-16. - Neighborhood Business (B-1) Zone.

- (b) Principal Uses. (Other uses substantially similar to those listed herein shall also be deemed permitted.)
 - 10. Private clubs.
 - 37. Animal grooming facilities.
 - 38. Mail service facilities.
 - 39. Tattoo parlors.
- 40. Form-based neighborhood business project, as per Subsection (o)(3) of this section.
 - 41. Commercial farm markets and market gardens.
 - 42. Establishments primarily engaged in agricultural sales and services, but only

when located within five hundred (500) feet of an Agricultural Rural (A-R) zone.

- 43. Ecotourism activities to include hiking, bicycling and equine trails; recreational outfitters, and canoeing and kayaking launch sites.
 - 44. Places of religious assembly.
 - 45. Offices of veterinarians, animal hospitals or clinics, provided that:
 - (a) All exterior walls are completely soundproofed;
 - (b) Animal pens are located completely within the principal building; and
 - (c) Boarding is limited to only animals receiving medical treatment.

Section 2 – That Article 8-16(d) of the Zoning Ordinance of the Lexington-Fayette
Urban County Government, related to conditional uses in the Neighborhood Business (B1) Zone, be and hereby is amended in pertinent part as follows:

- (d) Conditional Uses. (Permitted only with Board of Adjustment approval.)
- 20. Community Center
- 21. Adult Day Care
- 22. Day Center

Section 3 – That this Ordinance shall become effective on the date of its passage.
