TO HAVE AND TO HOLD said easement together with all rights, appurtenances, and improvements thereunto belonging unto said Grantee, its successors and assigns, for the purposes and uses herein designated.

The above-described temporary construction easement runs with the land for the duration of the improvement project and is binding upon the successors and assigns of the Grantor. The temporary construction easement shall take effect upon the commencement of construction of the project and will expire upon the completion of the project.

Grantor does hereby release and relinquish unto the Grantee, its successors and assigns forever, all of its right, title, and interest in and to the property to the extent of the interest conveyed herein, including all exemptions allowed by law, and does hereby

covenant to and with the Grantee, its successors and assigns forever, that it is lawfully

seized in fee simple of said property and has good right to sell and convey the same as

herein done, and that it will WARRANT GENERALLY said title.

The obtaining of this easement was authorized by Resolution 698-2017, passed

by the Lexington-Fayette Urban County Council on November 16, 2017. Pursuant to

KRS 382.135(2)(c), this temporary construction easement, which pertains to a public

right-of-way, need not contain a statement of consideration.
