

**AMENDMENT TO AGREEMENT**

**THIS AMENDMENT TO AGREEMENT**, made and entered into on this 3<sup>rd</sup> day of August, 2017, by and between **LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT**, an urban county government pursuant to KRS Chapter 67A, and located at 200 East Main Street, Lexington, Fayette County, Kentucky 40507 (hereinafter referred to as "Government"), and **GREENHOUSE17**, whose post office address is P.O Box 55190, Lexington, Kentucky 40555 (hereinafter referred to as "Contractor").

**WHEREAS**, Government and Contractor entered into an Agreement dated April 8, 2014 ("Agreement"), in which the Contractor was allocated \$67,900 in federal funds awarded to the Government by the U.S. Department of Justice, Office on Violence Against Women, under the Grants to Encourage Arrest Policies and Enforcement of Protection Orders Program;

**WHEREAS**, Government and Contractor entered amended the agreement referenced above on October 13, 2016 in which the Contractor was granted an extension to the Time of Performance through September 30, 2017;

**WHEREAS**, Government has agreed to modify the "Payment" section in the agreement, adjusting the allocation of dollar amounts between each activity;

**NOW, THEREFORE**, in consideration of the foregoing and mutually agreed upon promises, conditions, and covenants hereinafter set forth, the parties hereto agree as follows:

1. Article IV, "PAYMENT," shall be amended in its entirety to read as follows:


It is expressly agreed and understood that the total amount to be paid by the GOVERNMENT under this Agreement shall not exceed \$67,900. The CONTRACTOR shall invoice the GOVERNMENT monthly for the reimbursement of actual expenditures incurred. CONTRACTOR'S invoice must be for the expenses in the approved budget. CONTRACTOR'S invoice must include copies of payroll registers and signed timesheets for personnel costs. CONTRACTOR must provide documentation of the costs of all fringe benefits for which it is requesting reimbursement. Federal funds shall be used as follows:

1. Mental health and support services provided by a qualified counselor/mental health professional for victims of sexual assault in the context of domestic violence at a rate of up to \$50/hour for approximately 108 hours (\$8,400).
2. Supervision of LCSW student while providing individual counseling to victims to domestic violence (\$12,419.79).
3. Support a part-time victim advocate 15 hrs/week for a 3-year period (\$46,672.03).
4. \$408.18 shall be used to provide staff and materials for support groups developed in partnership with Bluegrass Rape Crisis Center for survivors of sexual assault within the context of domestic violence.

2. In all other respects, except as specifically modified herein, the terms of the Agreement dated April 8, 2014, shall remain in full force and effect with respect to the provisions outlined therein.
