AN ORDINANCE AMENDING THE CLASSIFIED CIVIL SERVICE AUTHORIZED STRENGTH BY ABOLISHING ONE (1) POSITION OF ENVIRONMENTAL OUTREACH SPECIALIST, GRADE 518E, AND CREATING ONE (1) POSITION OF ENVIRONMENTAL INITIATIVES SPECIALIST, GRADE 518E, AND CHANGING THE POSITION TITLE OF THE INCUMBENT, ALL IN THE DIVISION OF WASTE MANAGEMENT; ABOLISHING ONE (1) POSITION OF ENVIRONMENTAL OUTREACH SPECIALIST, GRADE 518E, AND CREATING ONE (1) POSITION OF ENVIRONMENTAL INITIATIVES SPECIALIST, GRADE 518E, AND CHANGING THE POSITION TITLE OF THE INCUMBENT, ALL IN THE DIVISION OF ENVIRONMENTAL SERVICES, EFFECTIVE UPON PASSAGE OF COUNCIL.

BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That subsection line number 350.044 in the classified civil service authorized strength be and hereby is deleted.

Section 2 – That the following subsection line number in the classified civil service authorized strength be and hereby is created to read as follows:

Section 3 – That the job title of the incumbent, Lauren Monahan, be and hereby is changed from Environmental Outreach Specialist to Environmental Initiatives Specialist, at the same grade and rate of pay.

Section 5 – That the following subsection line number in the classified civil service authorized strength be and hereby is amended to read as follows:
