I have reviewed this request for a resolution authorizing the Mayor, on behalf of the Urban County Government, to execute Contract Modification #1 to the Memorandum of Agreement with the Kentucky Transportation Cabinet (KYTC), for turf mowing and vegetation management services by the Division of Environmental Services on state-owned right of way, increasing the rate of compensation to the Urban County Government from \$35.00 per acre to \$36.00 per acre for areas along Citation Boulevard and from \$58.00 per acre to \$66.68 per acre for all other areas.
