September 24, 2019**

Vice Mayor Kay called the meeting to order at 3:10 pm. Council Members Ellinger, McCurn, Lamb, Evans, Worley, F. Brown, Bledsoe, Reynolds and Plomin were present. Council Members Moloney, Farmer, J. Brown, Gibbs, Farmer and Mossotti were absent.

Motion by Ellinger to approve the September 26, 2019 Council Meeting Docket. Seconded by Plomin. Motion passed without dissent, as amended.

Motion by Plomin to place ordinance #9, [an ordinance changing the zone from a Community Center (CC) zone to an Expansion Area Residential (EAR-2) zone, for 16.53 net (17.14 gross) acres, and to an Expansion Area Residential (EAR-3) zone for 8.09 net and gross acres for property located at 6600 Man O' War Boulevard] on the docket with a public hearing on October 22, 2019 at 5 p.m., Seconded by F. Brown. The motion passed without dissent, as amended.

Motion by Plomin to amend the date of the public hearing to October 29, 2019 at 5 p.m. Seconded by F. Brown. The motion passed without dissent.

Motion by McCurn to place ordinance #8 [an ordinance changing the zone from a High Density Apartment (R-4) zone to a Downtown Frame Business (B-2A) zone, for .119 net (.135 gross) acres, for property located at 171 Saunier St.] on the docket with a public hearing on November 12, 2019 at 5 p.m., Seconded by F. Brown. The motion passed without dissent.

Motion by Reynolds to place on the docket for Thursday, September 26, 2019, Council Meeting, a resolution authorizing and directing the Division of Traffic Engineering pursuant to Code of Ordinances Section 18-51, to install traffic calming devices on Gibson Avenue between Devonshire and South Broadway. Seconded by Lamb. The motion passed without dissent.

Motion by Lamb to place on the docket for the September 26, 2019 Council Meeting, a resolution authorizing the Mayor, on behalf of the Urban County Government, to execute and submit a Grant Application to the Kentucky Bicycle and Bikeway Commission's Paula Nye Memorial Bicyclist and Pedestrian Education Program, and to provide any additional information requested in connection with the Application, which Grant funds are in the amount of \$15,000 Commonwealth of Kentucky funds, and are for the operation of a public education program to promote the safe use of streets and trails. Seconded by Reynolds. Motion passed without dissent.
